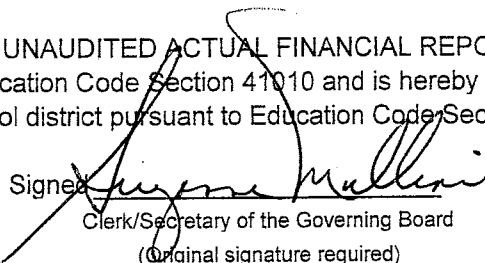

Part IV - Carry-forward Adjustment
