

Proposed Districting Timeline – By-Trustee Area Elections Cajon Valley Union School District (Subject to Change)	
August 22, 2017 Board Meeting	Board adopts resolution initiating change to by-trustee area elections/adopts tentative calendar
August 23, 2017 – September 11, 2017	District appropriately publicizes plans to hold public hearings and move to trustee areas
September 1, 2017	Publication of public hearing notices in newspaper of general circulation/posted at each school site and District office
September 12, 2017 Board Meeting	Presentations at Board meeting re (1) legal and policy criteria governing redistricting, and (2) demographics of District; first public hearing
September 26, 2017 Board Meeting	Presentations at Board meeting re (1) legal and policy criteria governing redistricting, and (2) demographics of District; second public hearing; Board adopts resolution specifying criteria for districting, provides instructions to demographer for the preparation of draft maps
October 10, 2017	Draft maps made publicly available
October 24, 2017 Board Meeting	Demographic consultant to publicly present initial draft trustee area plans; third public hearing; Board may order modifications to any of the draft plans
November 7, 2017	Deadline for District to make public any revised draft plans to be considered at November 14 public hearing
November 14, 2017 Board Meeting	Demographic consultant to publicly present draft trustee area plans, including any revisions; fourth public hearing; Board may order modifications to any of the draft plans
December 1, 2017	Publication of public hearing notice regarding waiver in newspaper of general circulation/posted at each school site and District office
December 5, 2017	Deadline for District to make public any revised draft plans in advance of December 12 public hearing
December 14, 2017 Board Meeting	Final public hearing; Board votes to adopt trustee area plan for submission to San Diego County Committee on School District Organization; public hearing on waiver application. ¹
January 2, 2018	District submits waiver application to State Board of Education; a waiver request normally takes approximately 10-12 weeks to analyze and process
January – March 2018	Public hearing(s) by County Committee regarding proposal to adopt by-trustee area elections and proposed trustee area plan
TBA	State Board of Education meeting at which it considers grant or denial of waivers ²
July 9, 2018	Legal deadline for submission of trustee area boundaries to county elections department, for implementation at November election (<i>as a practical matter, the boundaries should be submitted as early as possible to facilitate implementation by the County Elections Department</i>)
July 16, 2018	First day for circulating nominating papers
November 6, 2018	Election using new trustee area plan (assuming SBE grants waiver application)

¹ Prior to this date, the District to consult with collective bargaining units and any advisory committees/school site councils concerning the waiver application.

² Waiver decision subject to SBE Meeting schedule – dates for 2018 are not set yet, but the Board typically holds meetings bimonthly, starting in January.
