<p>Violation #55. Facilities installed, maintained, & clean Observed dusty A/C vent in dry storage room. Clean vent. CODE REFERENCE: 64E-11.003(5). Floors, walls, and ceilings shall be smooth, durable, easily cleanable, and non-absorbent. Exterior areas shall be kept cleaned.</p>
