If, during the course of the meeting covered by this Notice, the committee should determine that a Closed Session is required, then such Closed Session as authorized by the Texas Open Meetings Act, Texas Government Code Section 551.001 et seq., will be held by the committee at the date, hour, and place given in this Notice or as soon after the commencement of the meeting covered by this Notice as the committee may conveniently meet in such Closed Session concerning any and all purposes permitted by the Act, including, but not limited to the following sections and purposes:

Texas Government Code Section:

- 551.074 Deliberate the appointment, employment, evaluation, reassignment, duties, discipline, or dismissal of a public officer or employee or to hear a complaint or charge against an officer or employee.
- 551.076 Considering the deployment, or specific occasions for implementation, of security personnel or devices; or a security audit.
- 551.082 Considering discipline of a public-school child, or complaint or charge against personnel.
- 551.089 Considering security assessments or deployments relating to information resources technology; network security information described by Government Code section 2059.055(b); or the deployment, or specific occasions for implementation, of security personnel, critical infrastructure, or security devices.

Should any final action, final decision, or final vote be required in the opinion of the committee with regard to any matter considered in such Closed Session, then the final action, final decision, or final vote shall be either:

- (a) in the Open Meeting covered by the Notice upon the reconvening of the public meeting; or
- (b) at a subsequent public meeting of the committee upon notice thereof; as the committee shall determine.
