The Junior League of Lake Charles, Inc. (JLLC) is proud to offer the TEACH Grant as part of our 90-year legacy of community partnership in Southwest Louisiana. This unique \$5,000 grant involves community participation in the selection process. JLLC will select finalists from the applicant pool and prepare the online voting system which will open during the 2025 Mistletoe and Moss holiday market (November 14-16, 2025). Market attendees and the general public will vote for their favorite presentation, with one vote per day limit. The presentation receiving the most votes will be awarded the grant.

Applications, including electronic presentation materials, must be submitted by **October 11, 2025** to grants_scholarships@jllc.net. Finalists will be notified by October 25, 2025. Please note: in prior years, finalists were required to prepare physical presentations. As of the 2025-2026 League Year, all applicants are required to submit any electronic materials with the application. Electronic materials such as photos and graphics are optional but recommended. Failure to submit electronic materials will result in use of grant application materials as default for online voting purposes.

Electronic material guidelines: We employ a blind voting process. Please refrain from including any identifying factors in your electronic materials, including, but not limited to, your face, school name, logo, mascot, school colors, or photographs depicting identifiable students.

Although there are separate applications for the TEACH and Branch Out and Grow grants, applicants may choose to submit the same proposal for both programs or may tailor their applications for each. Applicants may also submit separate proposals for each grant given the different opportunities each grant may provide.

Applicants may submit proposals for both TEACH and Branch Out and Grow grants. Proposals may be identical or tailored for each grant, and applying to both programs is not required for consideration.

If selected as a finalist, applicants agree to submit electronic presentation materials adhering to JLLC guidelines.
