At Scranton Prep, we foster faith and religious relationships in our students by encouraging spiritual growth, nurturing a personal connection with God, and integrating Jesuit values into everyday learning and service.

The strange saga of Ross Roggio came to an end in a Scranton, Pennsylvania courtroom on Friday, April 15, 2024 where a federal jury found him guilty of a series of gruesome crimes and bizarre schemes. Prosecutors laid out a chilling case that included illegal weapons exports and acts of torture committed overseas—charges that ultimately resulted in Roggio receiving a 70-year federal prison sentence. The verdict marked only the second time an American has been convicted under the federal torture statute since it was enacted in 1994.

At the center of the case was FBI Special Agent Tom O'Donnell, Scranton Prep Class of 1987. O'Donnell first received a tip in 2016 about a suspicious transshipment of weapons tools from Connecticut to Pennsylvania and ultimately to the Kurdistan region of Iraq. Drawing on the values instilled in him during his Jesuit education—commitment to justice, service, and the dignity of all people—O'Donnell led an ad hoc task force alongside Homeland Security Investigations (HSI) to investigate the violations.

Over the course of eight years, the team conducted interviews, obtained grand jury subpoenas, and executed multiple search warrants to build the case. Roggio was first charged in 2018 with export violations. In 2022, a superseding indictment added charges of torture and conspiracy to commit torture based on his actions while running an illegal weapons factory overseas. He was sentenced in May 2024 to 840 months (70 years) in the Middle District of Pennsylvania.

**“This case is a testament to the courage and commitment of federal agents,” said U.S. Attorney Gerard M. Karam ’80. “Violence against the dignity and human rights of any victim cannot be tolerated, and our office will continue to prioritize and pursue those who would do so in violation of federal law.”**



Tom O'Donnell's unwavering pursuit of truth and justice is a powerful reminder of the impact one person—grounded in Jesuit principles—can have on the world. His work stands as a reflection of Scranton Prep's mission to form individuals who not only seek excellence but use it in the service of others.

Scranton Prep has a proud tradition of educating men and women who go on to serve with distinction in the fields of law and law enforcement. Grounded in the Jesuit ideals of justice, service, and intellectual excellence, our alumni have become dedicated attorneys, judges, police officers, federal agents, and public servants who uphold the rule of law with integrity and compassion. Their work reflects the values instilled at Prep—critical thinking, moral discernment, and a deep respect for the dignity of every person. We are honored by their accomplishments and grateful for the ways they continue to protect, defend, and advance justice in our communities and beyond.

# Jerry Karam '80 is a testament to Thomas Aquinas's philosophy that faith and reason coexist.



A product of Jesuit education, Karam has built a distinguished career in public service and the law. He began as an Assistant Public Defender in Lackawanna County before becoming Chief Public Defender for ten years. Karam spent 27 years as a partner at a prominent

Scranton law firm, focusing on civil and criminal litigation, and served as general counsel to the Housing Authority of Lackawanna County. Deeply involved in his community, he held leadership roles in several local organizations. In 2022, he was appointed by President Joe Biden as U.S. Attorney for the Middle District of Pennsylvania, serving until January 2025. This year, the Scranton Prep Alumni Office will bestow on Jerry the distinguished Rev. T. Donald Rinfret Award considering his work within our legal community and his practice with wisdom, compassion, and integrity—serving both truth and the people it's meant to protect.

Rev. T. Donald Rinfret, S.J., a Baltimore native and a 1943 graduate of Loyola High School, Towson, Md., served as Scranton Prep's Headmaster from 1966 through 1977 and when Prep was incorporated separately from the University,

he served as Prep's first president from 1977 until 1981. Under his guidance Prep had a number of firsts including being the first Jesuit secondary school in the country to admit women, the first Jesuit secondary school to have a lay principal (Mr. Daniel J. Kennedy, '54), the establishment of Prep's first Board of Trustees, and the initiation of the HAP Summer School program. He held Prep's first capital campaign in order to build the Larkin Center. Enrollment at Prep nearly doubled under his administration. Fr. Rinfret was embraced by the Scranton community and was very popular among students, faculty, and parents alike.

In 1982, the Scranton Prep Alumni Board of Governors decided to honor Fr. Rinfret by naming its highest award for him. It is awarded annually to a Prep graduate who has brought distinction to the school through the service of others, particularly in ways that reflect Prep's motto: Ad Altiora Natus.

Faith and reason work in harmony to shape moral judgments, allowing individuals to discern right from wrong with both spiritual insight and thoughtful reflection. Together, they form a foundation upon which Jesuit-educated men and women stand—not only to interpret and enforce the law, but to elevate it in service of a more just and compassionate world.

# Hello friends of Scranton Prep,

We always hope that our alumni have fond memories of their Prep experience. It may have been a teacher, a sport, the theatre program, and it's always friendships. During my years serving as a trustee, I've often heard two themes that are distinctly Prep — the commitment to faith and Jesuit education, and "Prep changed my life."

Our commitment to Jesuit Catholic education translates into a faith-based approach to everything we do. Faith shows up in our curriculum - and not just in religion class. It is the basis for how we expect our athletes to compete and our students to treat each other. It is the foundation of our service program, which is ubiquitous during the Prep experience and which reinforces a shared sense of responsibility - men and women for others! Ultimately, it forms a community of God-centered people. It unites us.

The goal, of course, is that we carry this ethos throughout our lives. My wife, Kelly, and I recently participated in an Ignatian pilgrimage led by Ryan Sheehan, our Director of Mission & Identity, and Fr. Rizzo. Decades after I left Prep, I was moved by the profound quality of praying and sharing the faith everyday with fellow Prep grads as we traveled through Spain and Rome. The foundation was built at Prep.

Changing lives is something I've heard from alumni, but now I hear it from current students and recent alumni. In part this is because Prep is exceptional among schools in northeastern Pennsylvania. It is also attainable for more academically qualified students who once could not afford Prep. If there is one development at Prep that reflects a sense of responsibility, it is the ability to make Prep a reality for so many more students.

This is why we ask you to participate in our annual campaign. We have exactly two sources of revenue at prep: tuition and donations. The latter accounts for about 35% of our budget and helps nearly two thirds of our families. It is how we change lives.

Your generosity makes this possible. We hope that you support our annual appeal this year.

# Signature Programs at Scranton Prep

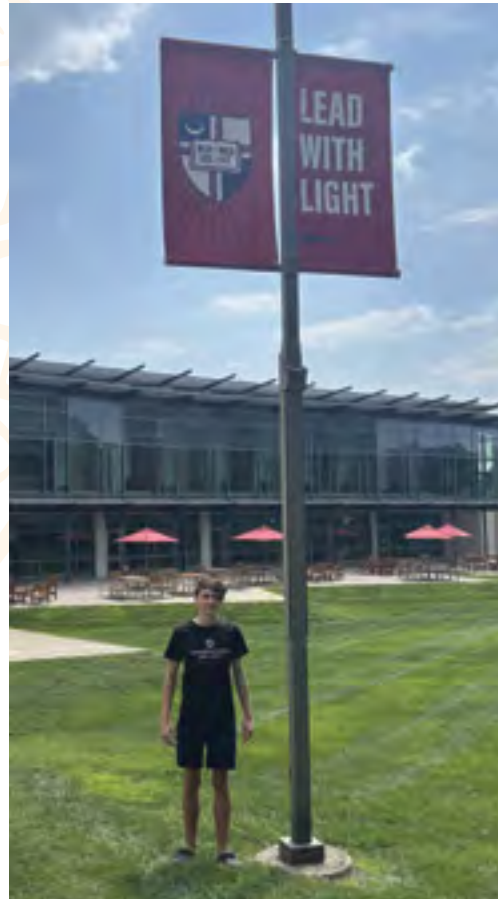
Dr. David Blazes '87 has generously funded a Signature Health Interest Program at Scranton Prep. The goal of this program is to provide our students with unique opportunities to explore careers in health care, gain valuable experiences, and bring that knowledge back into the classroom.

Thanks to Dr. Blazes' support, we can offer stipends to help students cover the costs of approved academic or practical health-related programs. If your son or daughter is interested in attending a program in health studies this summer, we encourage you to contact the Alumni Office.

If the program meets the established criteria, your student may be eligible to receive expense assistance from this dedicated fund.

This summer, Aiden Thompson '27 attended The Catholic University of America's Engineering New Frontiers Institute Summer Program.

"The CUA Summer Engineering Program was designed to introduce students to several different branches of engineering and help us see what each major might be like. One of the most memorable sessions for me was with the biomedical engineering department, which focuses on creating technology to address medical challenges. After

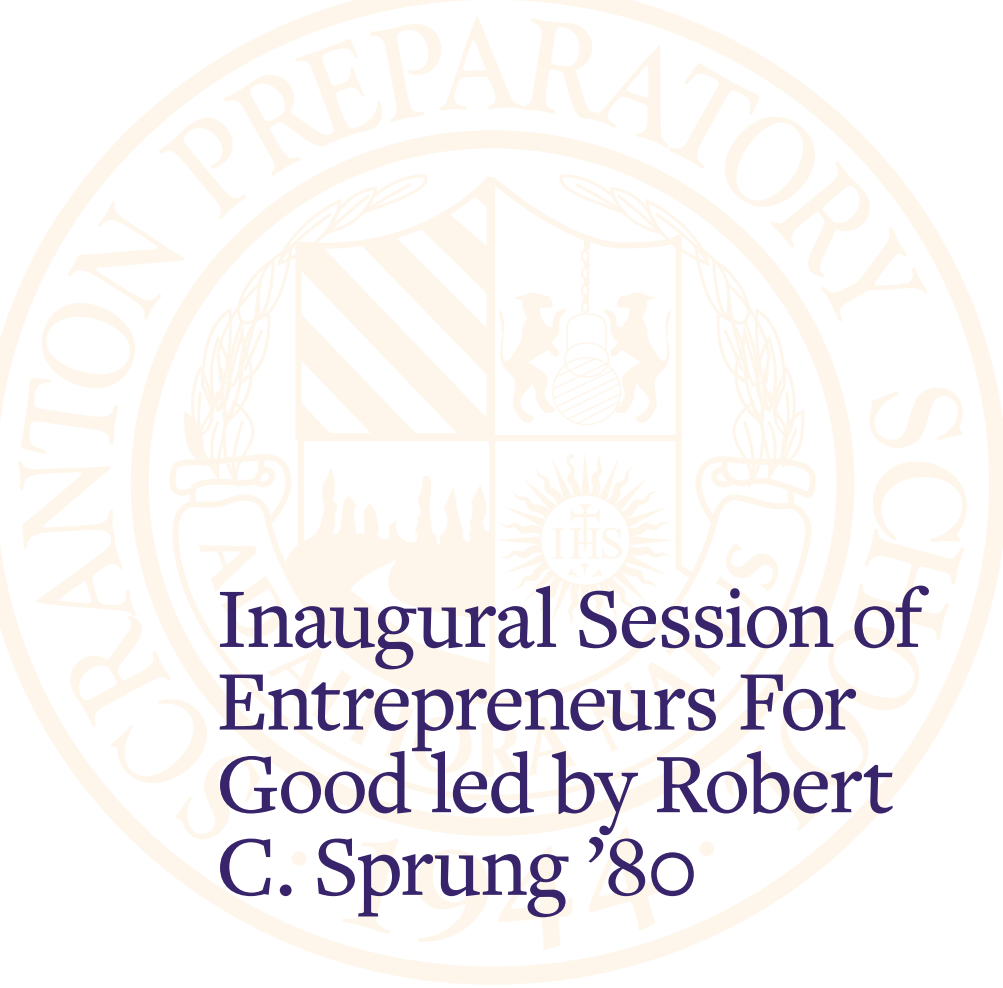


hearing presentations from professors, we toured a lab where students were working on a fascinating project to replace cancerous blood vessels. Using images of blood vessels just millimeters wide, they input data into a UV scanning machine that cut through resin to create exact replicas. Once the resin hardened, another gel was inserted, and the result was an accurate model of the original vessel. The goal is to use blood cells instead of gel to "grow" new, healthy vessels to replace damaged ones.

Beyond the academic side, the program also gave us a taste of college life. We experienced dorm living, explored Washington, D.C. through tours of monuments, and even went to a baseball game. Overall, the program was a fun and eye-opening way to explore engineering while also seeing what campus life at CUA is like. I was really impressed by both the campus and the city, and the experience has convinced me to add CUA to my list of colleges to consider."

## Inaugural Session of Entrepreneurs For Good led by Robert C. Sprung '80

Scranton Preparatory School successfully concluded the inaugural session of Entrepreneurs for Good, a groundbreaking summer program designed to empower students to create socially impactful ventures through entrepreneurship.

Held from July 14 th to 25th, the two-week program welcomed fifteen select students who immersed themselves in the fundamentals of business planning, leadership, marketing, communication, and ethics with a focus on service and social responsibility.

The program was developed and led by Robert C. Sprung, a 1980 graduate of Scranton Prep and a Harvard and Cambridge-educated entrepreneur. Sprung is the founder of Sprung Translations and has taught at prestigious institutions including Phillips Academy Andover and Harvard-affiliated programs. Drawing from his successful course at Andover, Sprung tailored Entrepreneurs for Good to reflect Prep's Jesuit values and commitment to forming men and women for others.

“Social entrepreneurship gives students the tools to create purpose-driven ventures—whether it’s tackling poverty, expanding access to education, or launching community service projects,” said Sprung. “We’re helping students see that they don’t have to wait to make a difference—they can start now.”

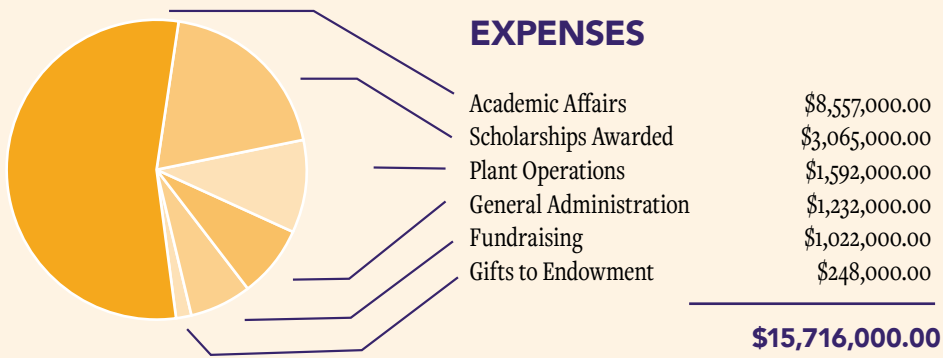
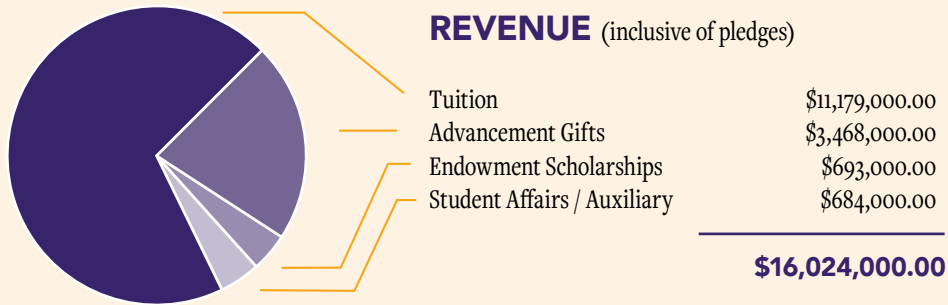
