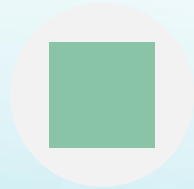

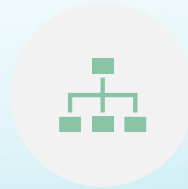

# INFRASTRUCTURE

## Previous meeting:

- The amendment to the Smart Schools Bonds Act was approved.
- We are drafting a new SSBA amendment to fund Interactive Display replacements, but progress is delayed as we await updated cost estimates following tariffs.
- Summer project: Upgrade all computers to Windows 11, since support for Windows 10 ends in October 2025.
- Purchased 20 desktop computers to replace those incompatible with Windows 11.

## Updates:





- The SSBA amendment to allocate funds for Interactive Displays has been approved.
- Majority of devices have been upgraded to Windows 11; a few still require replacement.
- Desktop replacements were acquired during the summer.



# PARENT BILL OF RIGHTS (PBOR)

- PBOR offers information to parents, guardians, and eligible students regarding specific legal obligations that safeguard personally identifiable information under state and federal laws.
- The NYS Education Department had new PBOR guidance.
- Mr. White revised the documentation to ensure compliance with the regulations in the Spring of 2025.
- One of the requirements for PBOR is that the District adopts the National Institute of Standards and Technology (NIST) Framework 2.0 as its cybersecurity standard.
