IMPORTANT CONDITIONS

1. The student and parent/guardian are required to notify the coach or instructor, department chair or director, and school administrator at least 24 hours in advance if providing their own transportation.
2. If the coach or instructor, department chair or director, and school administrator decide that self-transportation for this particular event is inappropriate, the student and parent agree the student will use district-provided transportation.
3. Permission to provide own transportation is conditionally approved by the coach or instructor, department chair or director, and school administrator and can be revoked at their discretion at any time.

4. The undersigned accept and assume any and all risks associated with transportation to and from the described activity, including but not limited to injury to self, family, third parties, or property.
5. The undersigned agree to release, indemnify, defend, and hold harmless Douglas County School District, its officers, agents, employees, and volunteers from any and all claims, demands, losses, damages, and expenses, including legal fees and costs, arising out of any liability or damage to property or other loss sustained or claimed to have been sustained during the transportation described above.
6. It is understood and agreed that the district is not responsible for verifying insurance coverage for private passenger vehicles not owned by the district, and the district's liability insurance will not become secondary should private insurance limits be inadequate.
