I. **Welcome** Mrs. Gomez 5 min.

Mrs. Gomez called the meeting to order at 9:10 am.

II. **New Business** Ms. Salazar 45 min.

Ms. Salazar presented the proposed School Improvement Plan for FY26, including the Vision and Mission of New Horizons Elementary. Background information including last year's SIP was presented, along with demographic information.

Ms. Salazar continued to share FY 25 Data- which included 3rd Grade ELA, Overall ELA, Math and Science proficiency levels. She also shared ELA and Math Gains, as well as ELA and Math Low 25. She also shared and reviewed the percentage of subgroups meeting proficiency.

Data Reflection included Ms. Salazar shares the most improved areas, our biggest needs, largest gaps and barriers hindering the growth. She explained some top priorities: 3rd Grade proficiency in ELA, SWD in all content areas, proficiency in foundational skills in grades K- 2, increasing learning gains and L25 and attendance.

Ms. Salazar presented the areas of focus which included ESSA Subgroup: SWD (Students with Disabilities) and the RAISE School Focus. She included

measurable outcomes along with the Monitoring/Action Plan for each of the areas of focus.

Ms. Salazar explained Roots and Wings- a tutoring program that will include seven groups of the Low 25 students to help close learning gaps.

The question was posed by Ms. Gomez to vote for the approval of the proposed School Improvement Plan for FY 26. All in favor raised their hands and the vote was unanimous for approval.
