**DUAL LANGUAGE STRATEGIC REPORT**

**SITUATION**

District staff have conducted a comprehensive Dual Language (DL) Strategic Planning Analysis in partnership with The Canizales Group to assess the effectiveness and impact of the Dual Language program and to chart a course for continued growth and excellence.

The analysis involved three phases: Virtual Empathy Interviews, Data Analysis, and Site Visits & Focus Groups. The major findings and next steps are being presented to the Board of Directors.

**BOND DEVELOPMENT UPDATE**

**SITUATION**

Members of our bond consultancy team from Turner & Townsend Heery and Teater-Crocker will join the Board tonight in person to introduce themselves and share an update on where our bond development process stands.

The Bond Development Committee has met twice so far this fall: September 18, and October 2. Subsequent meetings are scheduled for October 15 and 30, November 13, and December 3.

The consultants will share the structure and format of the meetings, provide a high-level overview of what's been shared with the committee thus far, and give a preview of what's to come in the upcoming meetings.

The plan is to provide the Board with another update in December about the package(s) that will be shared at public open house meetings in January and February.
