A Summary of the Board of Trustees Meeting

August 25, 2025

The Board of Trustees of the Corsicana Independent School District met in a Board Meeting at 5:30 p.m. on Monday, August 25, 2025 at the Corsicana ISD Dr. Kent Rogers Administration Building, 2200 W. 4th Ave., Corsicana, Texas. The meeting was called to order by Brad Farmer, President of the Board of Trustees.

Call to Order

Adopt the Tax Rate
