The Title 1 presentation also covers the Title 1 requirements, Parents' Right-to-Know, the District Title I Parent and Family Engagement Plan, and opportunities for parents to be involved in their child's education and as a volunteer at the school. A handout is provided for all attendees with a written summary of the information covered in the meeting. The school holds a Title 1 parent meeting to present Title 1 requirement, Parent's Right-to-Know, the school Title 1 Parent and family Engagement Plan, and Title 1 set aside family funds.

In addition to the Parent Information Meeting held annually, Appalachian School holds a "Meet the Teacher" day prior to the opening of school, encourages parents to be involved in PTSO, Athletic Booster Organizations, fundraisers, and to volunteer to serve as Classroom Adult Academic Volunteer. Meetings are offered at a varied of time to accommodate working parents. Teachers offer flexibly with conference's for parents who cannot come to the school.

Appalachian High School's CIP team consists of 1 parent from outside the school, two student and 11 employees. Parents are encouraged to make suggestions and are included in all meetings regarding planning, revising and approving the CIP. An annual Parent Survey is conducted each spring; the results and all comments are summarized by the LEA Parent Involvement Specialist and given to the school's principal for reference while planning the school's CIP. All parents are encouraged to submit their suggestions via email or in writing to the school's principal or vice principal.

At the present time, Appalachian has approximately 78 EL students (EL1 or EL2). Information on school meetings, parent notices, etc., is sent to EL parents in Spanish. Parents of 46 students indicated on Powerschool Registration that they required translations. All Hispanic families receive the annual parent survey, provided by the District, in English and Spanish. The Migrant/ELL Home Liaison is available to translate any written communication between the home and school. Information on the parent involvement link of the www.blountboe.net website is posted in both English and Spanish. The Home Liaison also attends IEP, parent/teacher conferences and disciplinary meeting upon request from either the school or the parent. The Home Liaison translates at parent meetings when needed.

Appalachian makes every effort to work with parents in meeting their requests as related to their involvement in their children's education. Grades, as well as ACT and ACAP scores will be explained when a parent requests information. Newsletters are sent home with students in grades K - 6. Progress reports are given every 4 1/2 weeks to all students. Information is also updated frequently on our school's website and social media pages. The LEA Parent Involvement Program provides age-appropriate newsletters.

Translators and sign-language interpreters are on staff with the Blount County Board of Education to ensure that all parents are able to understand the information being presented. All schools and facilities are handicap accessible. Reports and information, including student progress notes and report cards, are available in Spanish, or other languages (as needed). Special accommodations are continuously made to communicate with parents by phone and home visits as needed. A Migrant Liaison is on staff at the Blount County Resource Center, with a direct phone line, offering a wide variety of supports which also include the following: - Translating and support at all events including I.E.P. meetings and school functions - Translation of all written materials including Parent compacts, student handbook, newsletters, progress notes, report cards, etc. - Home visits to encourage school attendance and respond to needs that may not be expressed at the local school (tutoring needs, clothing, hygiene, food, medical, immunizations, dental, vision, financial aide, school supplies, etc.) - Pre-K support and enrollment in Headstart programs (multiple locations)- Outreach and identification of migrant families (posters, flyers, school notifications, dedicated direct phone line, booths at local events to inform parents of EL and migrant students of support services, etc.) - Professional Development for teachers to better serve students - Grade monitoring for all migrant and EL students with support provided for at-risk (drop out, failing, poverty) students - Information provided to parents about student options for College and Career Readiness (Career Tech, ACT testing support, and dual enrollment).
