RE: Notice of Advanced Removal and Depositing of Early Voted Ballots for November 4, 2025, General Municipal Election

Under the provisions of “The Votes Act,” early voting ballots may be processed in advance of the Municipal Election Day. The City of Medford Election Commission will conduct **Advance Removal** of Early Voted Municipal Election ballots. The Early Voted ballots will be removed from their sealed envelopes and prepared for Advance Deposit at Medford City Council Chambers, 85 George P. Hassett Dr, Medford, MA 02155 on the following days and start times:

The **Advance Depositing** of Early Voted Municipal Election ballots will be conducted at Medford City Hall, 85 George P. Hassett Dr, Medford, MA 02155 on the following days and times:

The Early Voted Ballots will be placed in a tabulator and counted. The results from Advance Depositing will not be determined nor announced until after the polls close at 8:00PM, on Tuesday, *November 4, 2025*, Preliminary Municipal Election. The results from the Advanced Depositing will be added to the Election Day results and posted in a public place.

All processes will be open for public observation.
