Statement of Purpose

Mary Orr Intermediate fosters an atmosphere of academic achievement and community pride. Through collaborative efforts of staff members, parents, and students we will increase the academic success of all students.

Goals

I. Provide parents with the opportunity to have input in the parent involvement plan at the district level and at their child's school.

- Parent and Family Engagement Policy

Mary Orr Intermediate will provide parents with a copy of the Parent and Family Engagement Policy via the school website and email. - Annual Parent Meeting
