MINUTES OF THE REGULAR MEETING OF SEPTEMBER 8, 2025

A regular meeting of the Board of Education of Independent School District Number One of Tulsa County, Oklahoma, was held on September 8, 2025, commencing at 5:32 p.m., in the Cheryl Selman room, ground floor, at the Charles C. Mason Education, 3027 S. New Haven Avenue, Tulsa, Oklahoma. G.1 RECOMMENDATION: Approve the 2025-2026 sinking fund Estimate of Needs and Requirements to retire bonded indebtedness for Tulsa Public Schools.

G.3 RECOMMENDATION: Revise the mascot visual imagery, depicting Native Americans, on Webster High School and Webster Middle School branding elements and structures, and authorize the Superintendent to develop a replacement mascot visual imagery, with input from appropriate stakeholders, to be presented to the board at a future meeting, pending approval of Policy 2623.

Vice President Moniz made the **motion**, and the motion was **seconded** by Ms. Stacey Woolley.

Mr. Croisant asked a question to clarify if the vote would be to change the names warriors or braves or just the imagery of those mascots. Superintendent Johnson responded that this request is not to change the Webster mascot from warriors or the Central mascot from being the braves, but rather this is a vote to change the imagery depicting those mascots. There was continued discussion among the superintendent and the board, and the motion **passed** by the following vote:

There being no further business to come before the board, the meeting was adjourned at 6:43 p.m.

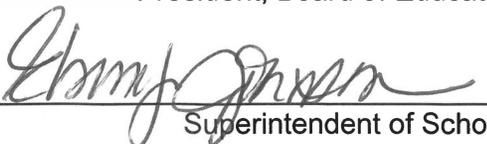
