

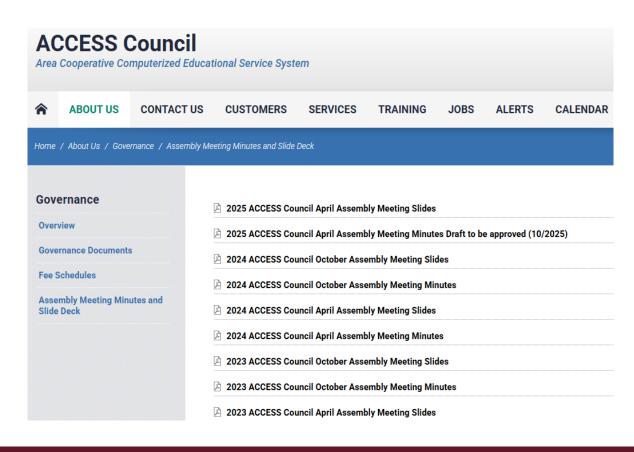

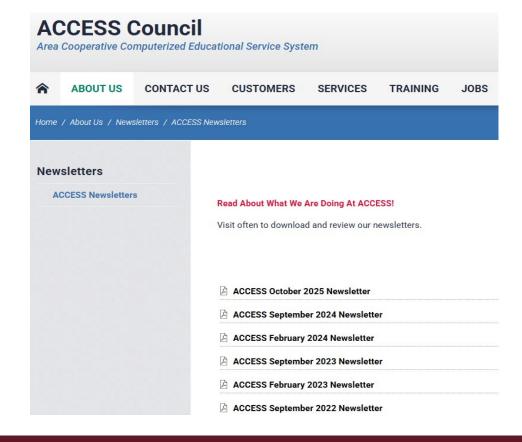

FINANCIAL UPDATE CONT.

Forecast projects NO changes to the current fee structure.

Key variables that can have an impact on our finances.

- Erate appeal decision from the Supreme Court In June 2025: The Universal Service Fund (USF) is constitutional, finding that it does not violate the separation of powers clause
- Final costs for upcoming projects/purchases
- Ever increasing need for additional security requirements
- Increases from Software/Maintenance providers
- Health insurance holidays or premium cost increases

Vote for approval of Financials

APPROVE FY27 FEES

NO changes to the current fee structure for FY27.

Possible future considerations:

- Aligning ADM counts to July #2 payment from SFPR report
- At first glance, fee increase due to the reduction in ADM, but our goal is to maintain consistent revenues & contract amounts
- Plan to engage Finance Review Committee to evaluate and recommend
- More to come Spring 2026 Assembly meeting

ADMINISTRATIVE UPDATES

ACCESS Council Erate audit Ongoing since January 2025

- USAC Audit and Assurance Division: Beneficiary & Contributor Audit Program (BCAP)
- ACCESS & thirteen of our member districts chosen. Cat1 & Cat 2
- Audit period was Funding Year 2023 (Our fiscal '24)
- Purpose of the audit is to determine compliance with FCC rules and Erate program requirements for the applicable funding year
- All of the fieldwork testing has been completed, draft report has been released to us, and it is under USAC review
- Once USAC review is finalized, it then moves on to the FCC for final approval
- Expected completion date is December 12, 2025

ADMINISTRATIVE UPDATES

Cat 1 Internet contract renewal

- If the Renewal Term is exercised for the same services, will not have to file a new Form 470. Refer to the originating Form 470 on the Form 471
- Districts would still have to file a Form 471 each year to cover the renewal period of three years
- If you have not provided us with written notice of non-renewal by the date set forth in the contract (January 1, 2026), we will follow-up and affirm your continuation of service for an additional three-year term through June 30, 2029. This will provide documentation memorializing the continuation of services. Notification will be sent via e-mail.

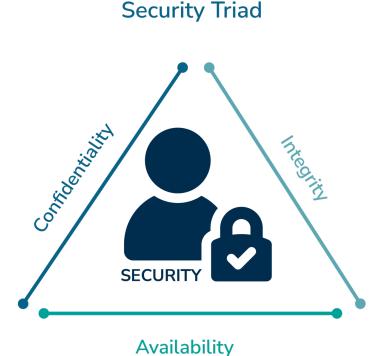

 - o Number (16383)
 - o Special Character(\$%&*#)
- 365 Day Password Expiration
 - Unless your entire district is MFA Enforced!!!
