- 1. Thirty (30) Project Duration is for base bid only. Additional days will be allotted for any alternate accepted.
- 2. Duration is Thirty (30) calendar days.






- 3. Provide Unit Prices for the following:
  - Muck & Fill: p/Cubic Yard
  - Cut and remove roots from drives and parking areas.
  - Additional Stone Base: p/Cubic Yard
  - Additional Asphalt: p/Ton
  - Additional Striping
  - Replace Concrete Curb: p/Linear Ft.
  - Replace Wheel Stops: p/Unit

#### Drawings:

- 1. Adhere to Asphalt Detail #2
- 2. Asphalt Detail #2 applies to all five (5) alternates
- 3. Proof roll areas after Asphalt demo is complete.
- 4. Item #4, Delete Thermoplastic Striping. Provide standard striping, to include Handicap spaces.
- 5. KCI will monitor proof rolls, muck & fill, and asphalt placement.

#### **Questions: Answers in Bold**

- 1. In regards to the wheel stops; Should we provide a unit price for new ones based on the damaged ones currently in place? I was onsite today and noticed there are multiple wheel stops that are already broken into several pieces. I was thinking this could be treated like the curb and the quantity be agreed upon during construction. Provide unit prices for standard wheel stops.
- 2. There is very little to no visible striping on the existing pavement of Alternate 1, will the School district provide this? Striping for Alt. #1 will be determined in the field and will follow existing as close as possible.
- 3. Will we need to plan on placing the speed bumps back in the same locations for Alt 3 & 5? Will we get a detail for this? **Replace speed bumps in the same locations, no detail will be provided.**
- 4. Will there be drainage details or elevations? There will be no drainage details, adjustments if necessary will be made in the field.
- 5. Alt 3 and Alt 5 at Marion High school have subsurface root intrusion that has damaged the asphalt. Does the school district or engineering team have a recommended method of removal? Will there be a separate line item in the bid to account for this? Provide a unit cost for root removal at impacted areas.
- 6. Will full access be available for the re-surfacing work? Vehicles will be relocated to other areas to allow for access. Please note the upcoming one (1) week break for the Thanksgiving holiday.
- 7. Looking over the plans sent to me for this project. I only see one scale drawing for the Base Bid but nothing for the Alts. Is there a striping plan for these? What is the plan for these areas; mill and overlay? If so, how thick to cut and replace? Any other information would be greatly appreciated. The cut details shown for the base bid will apply to the 5 alternates. The intent is to remove the existing asphalt and proof roll the existing substrate. All bids should be as noted on the base bid details, demo existing asphalt excavate 6" of existing substrate. Provide 6" of new base, proof roll and provide 2" of new asphalt.
