Required Documents for Registration



All documents can be directly uploaded to Cambrian's online registration system.

- Proof of Age:** An original Certified Birth Certificate, Birth Record, Baptism Certificate, or Passport along with a parent/guardian photo ID. (required)

- Proof of Immunizations:** Vaccines from another country must be transcribed. (required)
 - DTap/DTP/DT: 5 doses, 4 okay if one given after 4th birthday, 3 okay if one given after 7th birthday
 - Polio/IPV/OPV: 4 doses, 3 okay if one given after 4th birthday
 - Hep B/HBV: 3 doses
 - MMR/MMRV: 2 doses
 - Varicella/Chickenpox/VAR/MMRV: 2 doses
 - 7th grade requirement TDAP: 1 dose

- Proof of Residency:** Two (2) forms of address verification for all students: ONE (1) document from List A and ONE (1) document from List B. Both documents must include the name of the parent/guardian and the current residential address. (required)

Please note: Cambrian School District reserves the right to make home visits in order to verify residence at any time. Falsification of any information or documents required for residency verification or the use of the address of another person without actually residing there may result in the immediate revocation of student enrollment (Cambrian School District Board Policy 5111.1).

- Proof of Tuberculosis Skin Test or Tuberculosis Risk Assessment:** Immunization record and must include the test date and results. If there is no proof of a TB skin test on record, a TB Risk Assessment Form must be completed by a licensed healthcare provider in the United States. Or you may contact our District Nurse for more information.

- Special Education Students:** A signed copy of the most current IEP or 504 plans must be uploaded to Cambrian's online registration system. (required)

- 1st through 8th grade Students:** Most recent report card. (optional)

- TK Students & Kindergarten Students:** Additional required form below:
 - An Oral Health Assessment: California requires your child to have a dental check-up by May 31 of their first year in public school. (Educational Code Section 49452.8)
