We experienced an increase in restricted federal and state revenue in 24-25 that will continue in the 1st and 2nd subsequent years. These restricted funds cannot be used to supplant ongoing expenditures, like salaries and benefits, so we used them for many one-time and temporary expenditures which increased the percentage of unrestricted funds spent on salaries and benefits. We anticipate adding approximately 250 - 300 students in FY 2026-2027 and will minimize adding costs beyond salaries and benefits in order to keep projected deficits as low as possible.
