Medicine Crow MS is committed to the goal of providing quality education for every child in this district. To this end, we want to establish partnerships with parents and with the community. Everyone gains if Medicine Crow MS and home work together to promote high achievement by our children. Neither home nor Medicine Crow MS can do the job alone. Parents play an extremely important role as children's first teachers. Support for their children and for the school is critical to children's success at every step along the way.

Medicine Crow MS recognizes that some students may need the extra assistance available through the Title I program to reach the state's high academic standards. Medicine Crow MS intends to include parents in all aspects of the school's Title I program. The goal is a school-home partnership that will help all students to succeed.
