

# Krum Independent School District Chromebook Agreement 2025-2026

I acknowledge that my student and I have received the following documents in addition to an assigned Chromebook. As a parent/guardian, I will ensure that my student and I will read the documents before my student brings his/her assigned Chromebook to school for the first time.

- Krum Independent School District Chromebook Agreement
- Krum Independent School District Responsible Use Agreement

## ***Student Agreement***

As a learner, I agree that I will:

- use my assigned Chromebook for educational purposes only;
- follow the procedures and policies outlined in the Krum ISD Chromebook Guide and Krum ISD Responsible Use Agreement both at school and at home;
- protect my assigned Chromebook by carrying it securely and safely;
- never leave my assigned Chromebook unattended in an unsecure or unsupervised location;
- charge my assigned Chromebook's battery to full capacity each night;
- report all damages to or issues with my assigned Chromebook to school personnel;
- never alter or attempt to change the management setting on my Chromebook;
- and never share my assigned Chromebook with other students or individuals.

I understand that any violation of this agreement may result in the suspension or loss of my Chromebook and school network privileges. Additionally, I may face disciplinary action for such violations.

## ***Parent Agreement***

I understand that my family's responsibilities include:

- ensuring my child meets the expectations outlined in the Krum ISD Chromebook Guide and the Krum ISD Responsible Use Agreement;
- protecting my student's assigned Chromebook, within reason, against damage, loss or theft while it is at home or outside of school; and ensuring my child reports damage to the school personnel.

In consideration of the privileges and opportunities afforded by the use of KISD technology resources, I hereby release KISD and its employees from any and all claims of any nature arising from my child's use or inability to use these resources, including but not limited to claims that may arise from unauthorized use of a Chromebook.

I also understand that it is impossible for Krum ISD to restrict access to all controversial materials and I will not hold the District responsible for materials accessed with a Krum ISD Chromebook.

I accept full responsibility for my student's use of his/her assigned Chromebook while not in a school setting and understand that my student's Chromebook use is subject to the same rules and requirements when used off-campus. I understand that my student's Chromebook privileges may be suspended or revoked for violation of this agreement.

**Insurance Agreement**

As part of their participation in the Chromebook program, students can purchase an optional protection plan for his/her assigned Chromebook. The cost of the protection plan is \$40.00 **Cash or Check Only (checks must have drivers license number on check)**. Under this plan:

- The District will provide coverage for one Chromebook repair per school year. Subsequent damages will be the responsibility of the student.
- The replacement plan does NOT provide coverage for the loss of a Chromebook and/or its accessories, cosmetic damage, or damages caused by intentional misuse and abuse.
- Replacement is at the discretion of the principal. Students will be responsible for the full cost of replacement (\$334.00) if it is determined that damage has been caused by intentional abuse and/or misuse.
- The District reserves the right to request parents/guardians to pay an optional protection fee annually. Claim history on loss, theft and damage, will ultimately determine whether additional fees are necessary beyond the original \$40 fee.

I understand that should damage occur to the Chromebook assigned to my child due to intentional damage, I will be solely responsible for reimbursing the school for repair or replacement costs.
