



Gun Violence Prevention for Parents & Guardians of K-12 Students

AS REQUIRED by state law ([House Bill 25-1250](#)), the Colorado Department of Public Health and Environment is making gun violence prevention material publicly available for educational providers to access and distribute to parents, guardians, and legal custodians of elementary or secondary school students. This resource outlines steps you can take to keep your children safe and reduce the risk of unintentional injuries, suicides, and firearm theft (Source:

Firearm Safe Storage

Research shows that hiding firearms is less effective than using secure storage methods. Children and youth often know hiding locations and can access firearms if not securely stored. In Colorado, most firearm deaths are by suicide (over 70%) ([CDPHE, Colorado Firearm Data](#)

[Dashboard, 2025](#)). In addition, one in three Colorado middle and high school students report they can get a firearm, with many of them able to do so in under 10 minutes. (Source: Wright-Kelly, E. et al., Perceived Access to a Loaded Firearm Among Youths in Colorado, JAMA Netw Open, 2025.)

Secure storage devices (e.g. trigger locks, safes) can be purchased from firearm retail and sporting goods locations

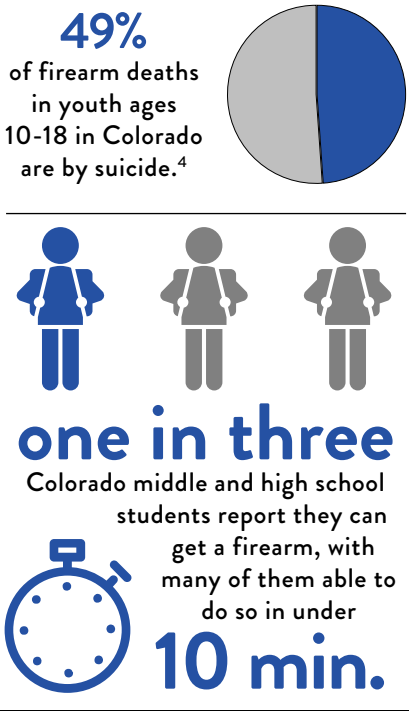
Reporting Lost or Stolen Firearms

Colorado law requires firearm owners to report a lost or stolen firearm to a local law enforcement agency within five days of discovering the loss or theft. Extreme Risk Protection Orders

Extreme Risk Protection Orders are a legal tool that can help

decrease firearm-related suicide and violence. Other tools include safe gun storage, voluntary out-of-home gun storage when someone is experiencing a crisis, and mental health and substance use treatment services. Extreme Risk Protection Orders (ERPOs) are issued by judges to temporarily limit access to firearms for individuals considered at risk of harming themselves or others.
