### **What is Title I?**

**Clinch County Elementary School is identified as a Title I School as part of the Every Student Succeeds Act (ESSA). Title I is designed to support State and local school reform efforts tied to the challenging State academic standards to improve teaching and learning for students. Title I programs must be based on effective means of improving student achievement and include strategies to support family engagement. ## **Clinch County Elementary Family Engagement Plan For Shared Student Achievement**

**What is a Family Engagement Plan?** This is a plan that describes how Clinch County Elementary will provide opportunities to improve family engagement in our school and support student learning. Clinch Elementary values the contributions and involvement of parents and family members to establish an equal partnership for the common goal of the improving student achievement. This plan describes the different ways that Clinch Elementary will support family engagement and how parents can help plan and participate in activities and events to promote student learning at school and at home.

**How is this Revised?** Clinch Elementary invited all parents to attend our annual Parent Feedback Nights in the spring and fall to review and revise this family engagement plan, as well as the school-wide plan, our school-parent compacts, and the family engagement budget. Additionally, parent input and comments regarding this plan are welcome during the school year through an online form on our website. The plan is posted on our school website for parents to view and submit feedback throughout the year. All parent feedback received during the year will be used to revise the plan for the next school year. We also send home an annual survey by our students and post the survey online asking our parents for their suggestions on the plan and the use of funds for family engagement. Parents and family members can also give feedback during several parent meetings and activities during the school year.

**Who is this for?** All students participating in the Title I, Part A program, and their families are encouraged and invited to fully participate in the opportunities described in this plan. Clinch Elementary will provide full opportunity for the participation of parents and family members with limited English, with disabilities, and of migratory children.

**Where is this available?** We will send home this plan with every student at the beginning of the school year. This plan will be posted on our website and a copy will also be kept in the Parent Resource Center.



## 2025-2026 District Goals

1. Increase the number of students scoring in the Accelerated Learning Category in the writing and language domain on **GMAS**
2. Increase the number of students at or above grade-level Lexile bands
3. Increase the number of students scoring levels 3 & 4 on the **GMAS**
4. Increase the number of students who are college and career-ready by improving academic readiness and support for students enrolled in rigorous college-preparatory courses
5. Reduce the number of students who receive multiple disciplinary referrals resulting in **ISS/OSS** by 5%

## 2025-2026 School Goals

Clinch County Elementary School administrators & teachers have studied our student performance data to find the most important areas of improvement for our school. The school goals for 2025-2026 are:

1. Increase by 15% the number of students scoring in the “Met Target” category on the Writing and Language domain on the **GMAS**
2. Increase the percentage of students scoring at least grade-level (Level 2 or above) and At or Above grade-level by 10%
3. Increase the percentage of students scoring in levels 3 & 4 on the **GMAS** Math assessment by 10%
4. Reduce the number of students who receive multiple disciplinary referrals in **ISS/OSS** by 5%

- ◇ Collect feedback and suggestions from parents and family members at all events and post a feedback and suggestions form on the school’s website in order to respond to parents’ requests for additional support for parent and family engagement activities.

## School-Parent Compacts

Part of this plan is for Clinch Elementary and families to develop a school-parent compact. This compact is an agreement that parents, students and teachers develop together that explains how parents and teachers will work together to make sure all of our students reach grade-level standards. These compacts will be reviewed and updated every year based on feedback from our parents, students and teachers during our Annual Parent Feedback Nights. The school-parent compacts are shared in October with parents by being sent home with each child and are kept with each child's teacher if a parent should need another copy.
