
















English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 











Students enrolled in one or more classes by discipline:







Students enrolled in one or more classes by discipline:







Staff



Mission, Vision, Theme:

Vision Statement: The Watchung Borough School District is committed to inspiring learners to explore, inquire, and collaborate on their joyful journey toward discovery, independent thinking, and creative problem solving. Our culture of acceptance and inclusion provides the foundation for learning and social and emotional growth. Through reflection and ethical decision-making, we continue to learn and grow, embrace differences, and prepare for an increasingly complex, every-changing world.



Awards, Recognition, Accomplishments:

Students have won robotics competitions locally, and nationally, Battle of the Books competitions, spelling bee contests, and Future Cities and Model UN conferences. They have earned basketball championships and won numerous band and chorus competitions. Bi-annually, the district performs a middle school play and showcases art projects. Bayberry Elementary School also performs plays and concerts, and was awarded the Bronze Level Certification from Sustainable Jersey for Schools.



Courses, Curriculum, Instruction:

In addition to a full curriculum aligned with the state learning standards (NJLS) in English language arts, mathematics, science, and social studies, programs offered include advanced mathematics, robotics, world languages, industrial arts, STEAM, a gifted & talented program, and integrated preschool. The district has begun to incorporate the Science of Reading into the existing Reading and Writing Workshop model along with using Foundations for phonics and phonetic awareness, learner-active technology-infused classrooms, 1:1 Chromebook initiatives for grades 2-8, iPads for grades K-1, SmartBoards, and educational software to enrich learning.

Students also participate in the Adventure Education Program. The program consists of swinging elements, rope climbing, knot tying, belaying techniques, balance beam courses, and group tasks that foster team work and communication.



Clubs and Activities:

A variety of clubs are offered to students. TREP\$ is an entrepreneur program for students who want to learn about starting their own business in the future. Girls On Track builds self-respect and healthy lifestyles while training for a 5K. Other favorites are the Environmental Club, Community Outreach, Peer Leaders, Student Council, Photography Club, History Club, Newspaper Club, Homework Club, Robotics/Coding Club, and Honor and Regions Bands. Students also serve on the Watchung Youth Services Commission.



Before and After School Programs:

The district operates a before and after-school option for grades PK-8 at Bayberry School. Morning care runs between 7:00-8:30 a.m. After-school care is available until 6:30 p.m., and offers a quiet area for homework, as well as fun activities for students. Students in grades 5-8 may be bused to Bayberry Elementary School from Valley View Middle School.

Staff and Professional Learning:

Faculty are valued and supported through meaningful professional learning and opportunities to work as colleagues and peer supporters. There are several multi-year district initiatives providing faculty and staff training. Innovative Designs for Education consultants provide whole school training on best practices in executive functioning and student achievement, meeting the needs of diverse learners, as well as, personalized coaching for teachers. Additionally, there are self-paced online learning experiences focused on Individualized Learning, Multilingual Learners, and Problem-Based Learning Experiences. Other training opportunities include Foundations PK-2, Conquer Math Grades K-8, Response to Intervention including implementing effective RTI process and high impact interventions, and developing targeted goals based on assessment data and frequent monitoring. ParaEducator training is also offered. Crisis Prevention Institute non-violent intervention techniques training is on-going.



Student Supports and Services:

The Department of Special Services includes a child study team and related service providers who respond to referrals, evaluate students, determine eligibility for special education and related services, and collaborate with parents/guardians and the school staff to set goals, and plan and implement programs and services that meet students' individual needs. The Department also oversees the referral, evaluation, and identification process for students who are eligible for 504 Accommodation Plans, and the School Counselors, serving as the 504 Case Managers, collaborate with parents/guardians and staff to develop accommodation plans to meet students' needs. English as a Second Language Programs and Services are available to eligible students whose home language, or primary language is other than English.



Parent and Community Involvement:

Watchung Borough is fortunate to have a highly supportive PTO and education foundation. Together, the PTO and the Watchung Educational Foundation (WEF) organize a variety of fundraisers designed to support and enrich the educational programs. The groups fund assemblies, workshops, and grants to enhance the curriculum. In addition, our Special Education Parent Advocacy Group (SEPAG) fundraises and provides opportunities that support and enrich our educational programs, including offering parent information and support.
