
















English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 











Students enrolled in one or more classes by discipline:







Students enrolled in one or more classes by discipline:











Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. In addition to a full curriculum aligned with the state learning standards (NJLS) in English language arts, mathematics, science, and social studies, programs offered include advanced mathematics, world languages, art, music, STEAM, and a gifted & talented program. Valley View uses an inquiry-based learning approach in Science, learner-active technology-infused classrooms, 1:1 Chromebooks, Smart Boards, and educational software to enrich learning.



Sports and Athletics:

Sports Offered: Baseball (Boys), Basketball (Boys & Girls), Softball (Girls), Track and Field - Spring (Boys & Girls)
Students also participate in the Adventure Education Program. The program consists of swinging elements, rope climbing, knot tying, belaying techniques, balance beam courses, and group tasks that foster team work and communication.



Clubs and Activities:

A variety of clubs are offered to students. TREP\$ is an entrepreneurial program for students who want to learn about starting their own business in the future. The Coding/Robotics Club offers students the opportunity to work with a variety of technological tools to become creative collaborators who solve team challenges. Other favorites are the Adventure Club, Environmental Club, Community Outreach, World Culture Club, Peer Leaders, Student Council, Photography Club, Drama Club, Select Choir and Honor Bands. After school care is available until 6:30 p.m., and offers a quiet area for homework, as well as fun activities for students. Students in grades 5-8 may be bused to Bayberry Elementary School from Valley View Middle School.



Staff and Professional Learning:

Professional learning is offered to teachers and administrators during the summer and throughout the school year. Teachers collaborate in PLCs and in our faculty book club.



Student Supports and Services:

Valley View has established and implemented a system for I&RS that is designed to assist students who are experiencing learning, behavior or health difficulties. The I&RS team meets regularly to form action plans and to review the implementation and success of the interventions. ELL students are identified and supported with instructional services. The child study team consists of highly skilled professionals including a social worker, school psychologist, and learning disabilities teacher consultant. A behaviorist and two speech and language specialists are members of the team. Occupational and physical therapy is available for eligible students. A basic skills program provides support for at-risk students.

Students are able to go outside during the lunch period or use the gym during inclement weather for additional physical activity time. Health classes are taught by our teachers and school nurse. A Watchung DARE officer teaches our 5th graders the dangers of substance abuse. Additionally, regularly scheduled Mountaineer Mondays focus on topics of Social, emotional, mental health and general well-being.



Parent and Community Involvement:

Valley View Middle School is fortunate to have an active and supportive PTO, SEPAG, and an enthusiastic and motivated Watchung Educational Foundation. Together, these groups organize a variety of fundraisers to enrich the educational programs. They provide assemblies, workshops, and grants to enhance the curriculum.



Facilities:

In 2024, the middle school library and art room were completely renovated as a student Learning Commons and state of the art Art Studio. In 2019 a new gym, industrial arts room, and three additional classrooms were build along with renovations to the existing structure. New heating and air conditioning were included in the project. In the summer of 2019, through the generous donation of a community benefactor, a state-of-the-art STEAM lab was built.

Other Information:

The district has high expectations for its students and staff and continues to provide exceptional educational opportunities for all students. Valley View has a seven period schedule with a 30-minute Intervention and Enrichment period. A Mountaineer Monday schedule is followed twice per month. During the Mountaineer Monday period a teacher works with a small group of students on academic, social-emotional, and school-wide culture building. Teachers use Google Classroom to communicate with students and post assignments and resources. The new STEAM lab includes a television studio, which allows students to broadcast daily announcements. School safety remains a top priority for the district. The safety and security plan includes important protocols to ensure the safety of our students and staff.
