
















English Language Arts and Mathematics Performance Trends









Students enrolled in one or more classes by discipline:













Additionally, in many elementary schools, teachers are not assigned to specific subject areas, so they will appear in the Elementary (Not Subject Specific) category and not in the other subject areas, but that does not mean those subjects are not being taught in the school. Special Education and Bilingual teachers are generally assigned to a subject area and also either special education or bilingual, so those teachers will be counted in multiple subject areas.

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. - Students in grades K-4 experience a balanced literacy program through Foundations for phonics, spelling and handwriting, as well as exposure to a variety of authentic literature in the reading and work
- Students in grades 2-4 have 1:1 Chromebooks. Students in grades K-1 have 1:1 iPads.



Mission, Vision, Theme:

The mission of Bayberry School is to introduce the young child to formal learning by building a foundation of knowledge and skills (NJSLs) within a nurturing environment that promotes self-confidence, encourages love of learning, and celebrates the uniqueness of each child.



Awards, Recognition, Accomplishments:

Students in every grade participate in an annual performance in the performing arts that includes all students at the grade level. Students in Kindergarten, 2nd grade and 4th grade perform a unique play incorporating drama, music and costumes. Students in first grade perform songs at their annual Harvest Festival and third grade performs a Recorder concert. In addition, students in fourth grade have the opportunity to participate in Band and perform in a winter & spring concert.

Courses, Curriculum, Instruction:

Bayberry Elementary School has begun to incorporate the Science of Reading into the existing Reading and Writing Workshop model along with using Foundations for phonics and phonetic awareness. GoMath aligns with the New Jersey Student Learning Standards for mathematics. The science curriculum is inquiry based, high interest, and meets the New Jersey Student Learning Standards for science. Students' individual needs are addressed through various services, such as the Gifted and Talented program, after-school clubs, literacy support, and special education. All students attend art, music, STEAM, physical education, and library classes on a weekly basis. Our full-day integrated preschool program utilizes Creative Curriculum, A's Pal's Social Emotional Curriculum and additional developmentally appropriate resources.



Clubs and Activities:

Various after-school clubs in arts & crafts, sports, chess, coding/robotics, and community service are offered to students. Our Pursuit of Excellence program is offered to students who require additional time to learn in a small group setting before or after school.



Before and After School Programs:

The district operates a before and after-school option for grades PK-8. Morning care runs between 7:00-8:30 a.m. After-school care is available until 6:30 p.m., and offers a quiet area for homework, as well as fun activities for students. Students in grades 5-8 may be bused to Bayberry Elementary School from Valley View Middle School.

Staff and Professional Learning:

Faculty are valued and supported through meaningful professional learning and opportunities to work as colleagues and peer supporters. There are several multi-year district initiatives providing faculty and staff training. Innovative Designs for Education consultants provide whole school training on best practices in executive functioning and student achievement, meeting the needs of diverse learners, as well as, personalized coaching for teachers. Additionally, there are self-paced online learning experiences focused on Individualized Learning, Multilingual Learners, and Problem-Based Learning Experiences. Other training opportunities include Foundations PK-2, Conquer Math Grades K-8, Response to Intervention including implementing effective RTI process and high impact interventions, and developing targeted goals based on assessment data and frequent monitoring. ParaEducator training is also offered. Crisis Prevention Institute non-violent intervention techniques training is on-going.



Student Supports and Services:

The child study team consists of highly skilled professionals including a social worker, school psychologist, and learning disabilities teacher consultant. Two speech and language specialists are members of the team and evaluate students in preK-4, when there is a concern in the area of language development. Occupational and physical therapy is available for eligible students. A certified Reading Specialist provides support for at-risk students. The Intervention & Referral Services (I&RS) Team provides support for students with academic, behavior and/or health concerns. The district also employs a behaviorist for students who need behavioral support.



Student Health and Wellness:

Students benefit from social emotional programs and strategies such as Responsive Classroom, Second Step and Little Spot of Feelings. Our guidance counselor is available to provide individual and group counseling, social skills coaching and targeted classroom lessons.

Parent and Community Involvement:

An active PTO is continually planning fundraisers and activities to support the educational program. The PTO has provided funds for Chromebooks, the creation of the STEAM lab, and individual grants to classroom teachers. The Watchung Educational Foundation helps to fund additional programs and activities for the students and for the teachers. Grants have been awarded for the learner-active, technology infused classrooms and for the science and STEAM Initiatives. WEF has funded the purchase of new iPads for grades K-1. A community benefactor donated a brand new state-of-the-art playground at Bayberry.



Facilities:

The district is currently undergoing facilities upgrades as the result of a referendum. These projects include site improvements, upgrades to the building envelope and building interiors, security, HVAC, electrical and plumbing systems, as well as a planned new outdoor learning commons. The last major renovation to the schools occurred in 2003. Bayberry School was expanded with additional classrooms and common space, including a full-size gymnasium and upgrades to a new library space. A STEAM lab also was added. Recent upgrades to address security measures have included a renovation of the foyer and main office.



Early Childhood Education:

Bayberry offers full day, inclusive preschool for students 3-5 years old. Tuition based preschool is offered on a limited basis. Teachers utilize The Creative Curriculum and AIs Pals Social Emotional program.

The safety and security plan includes important protocols to ensure the safety of our students and staff.
