Mission Statement

As a Sponsor of Community Schools, Mid-Ohio Educational Service Center's Mission is to establish strong public community schools by adhering to quality authorizing practices and oversight in accordance with the role of a sponsor, and to provide quality educational opportunities for students who may not otherwise participate successfully in a regular public school setting.

Sponsor Performance Evaluation

It is the goal of the Mid-Ohio ESC to adhere as closely as possible to the National Association of Charter School Authorizers (NACSA) Principles & Standards for Quality School Authorizing. Established in 2004, it is widely considered the national standard for the work of charter school sponsorship.

The Ohio Department of Education and Workforce (ODEW) utilizes the annual Sponsor Performance Evaluation, which is aligned with NACSA standards and Ohio-specific requirements. Community school sponsors are evaluated on three components: the academic performance of sponsored community schools; compliance with all applicable laws and rules; and adherence to quality sponsoring practices.

ODEW completed its Sponsor Performance Evaluation for the 2018-2019 school year and released the rating in November 2019. Mid-Ohio ESC received an overall rating of “Exemplary.” The component ratings were as follows: Academic Performance – “A”; Compliance – “Exceeds Expectations”; and Quality Practices – “Meets Standards”.

Mid-Ohio ESC accepted the incentive of maintaining its “Exemplary” rating while being exempt from the formal evaluation process. This incentive provides highly rated sponsors the opportunity to be evaluated once every three years (Exemptions were given for 2019-2020 and the 2020-2021 school years due to the Covid-19 Pandemic).

GOAL Digital Academy

Description of the School

GOAL Digital Academy is a public online community school, serving students in grades K-12, with a curriculum written to the Ohio Academic Content Standards. GOAL Digital Academy takes pride in creating flexible and innovative individual educational plans that support their students as they work to achieve their educational goals.

GOAL Digital Academy offers an array of educational services and programs for its students. Special education services and intervention classes are provided based on the students' goals identified in their Individual Education Plan (IEP).

Licensed teachers instruct GOAL Digital Academy's high school students, enabling them to earn flex credits, credentials, and an accredited high school diploma. Advanced placement courses and college credit are available. In addition to its standard curriculum, GOAL Digital Academy offers credit flexibility to its high school students. GOAL Digital Academy provides educational opportunities for students up to 21 years of age and up to 22 years of age when the student is on an IEP.

Licensed teachers instruct GOAL Digital Academy's elementary and middle school students (K-8), while parents provide support from home. GOAL Digital Academy's reading and math intervention programs help elementary and middle school students make multiple-year gains. Teachers act as partners with parents, who work with the students on a daily basis. Tutoring services at GOAL Digital Academy's learning labs are also available for all students.

There are seven physical locations/labs: Cardington, Delaware, Galion, Mansfield, Marion, Mt. Vernon, and Newark.

Finally, GOAL Digital Academy obtained an “Exceeds Standards” in their **Graduation Rate** component, which looks at the percent of students who are successfully finishing high school with a diploma in four, five, six, seven, or eight years. Fiscal performance is measured by solid work practices, accurate and timely financial reporting, sound internal controls, and accountability. As a sponsor of GOAL Digital Academy, Mid-Ohio ESC expects this same level of excellence in financial reporting and compliance from the school.

For the 2024-2025 school year, GOAL Digital Academy met the expected performance level for fiscal performance as follows:

Auditor of State audits – GOAL Digital Academy has a history of receiving excellent audit reports, which illustrates strong evidence of sound internal controls and accountability. The most recent State audit included an unqualified opinion was issued for 2023-2024, including no citations or findings for recovery.

GOAL Digital Academy’s Governing Board approved financial reports – The GOAL Digital Academy’s Governing Board of Directors approve all monthly financial reports.

Financial Oversight and Review – A critical component of GOAL Digital Academy's financial stability and success can be attributed to its strong leadership. The school's superintendent and treasurer have many years of experience overseeing the school and its finances. Their knowledge and understanding of community school law and finance is thorough and current. GOAL Digital Academy saw an increase in student enrollment during the 2024-2025 school year. Enrollment went from 838 FTE in the previous year to 887 FTE (49 FTE). The increase to enrollment resulted in higher revenues and a greater amount of expenditures for the year.

3. Organization and Operation – Exceeds

GOAL Digital Academy works with local and regional districts to enroll students who are behind normal matriculation and academic progress and who are considering leaving their home school district.

GOAL Digital Academy's priority is to support students with an educational plan designed to allow them to progress toward their educational goals and potential re-enrollment in their home school district. Thus, there is significant movement of students who enroll and leave the program to return to their home school district or to other educational settings.

GOAL Digital Academy in partnership with the sponsor follows the community school contract and exceeds compliance in all areas. GOAL Digital Academy Governing Board members have attended the Auditor of State training on Sunshine Laws, have completed paperwork for disclosure of conflicts of interest, and all have been fingerprinted. The Code of Regulations is followed in detail by the Governing Board of Directors for GOAL Digital Academy.


4. Legal Compliance – Meets

Throughout the term of the contract, adjustments/modifications to the contract for GOAL Digital Academy will continue to be made to reflect any major compliance changes that are enacted by the Board or to reflect any changes in law and rules in the state of Ohio that pertain to Community Schools.

The Tomorrow Center

Description of the School

The Tomorrow Center is a trauma-sensitive school. The Tomorrow Center offers students an environment that is understanding of traumatic events that students have experienced by providing staff support who have been trained in and who understand the trauma-informed practice.

The staff at the Tomorrow Center includes licensed teachers, a community civic engagement coordinator who is a licensed social worker, intervention specialists, Title I reading instructor, a success coach, an office manager, and teacher aides.

The Tomorrow Center recognizes the importance of family in helping students graduate. Parents Club meets monthly and these meetings are designed to promote academics and build trust with families. At an annual Open House, a community fair is held that aligns parents with 50 different community agencies. The Tomorrow Center also recognizes the importance of community partnerships and has had a community liaison for the past decade who will host quarterly community advisory committee meetings comprised of influential members of the community and business leaders who help create and sustain programming and provide needed resources for students and their families. When schools, parents, families, and communities work together to support learning, students earn higher grades, attend school more regularly, stay in school longer, and enroll in higher level programs.



The academy operates a physical drop-in lab in Findlay, providing additional support and tutoring services. Enrollment is open to any student in grades 9-12 who lives in the Findlay City School District, Ada, Arcadia, Arlington, Bluffton, Cory Rawson, Elmwood, Fostoria, Hardin Northern, Liberty Benton, McComb, North Baltimore, Riverdale, Van Buren or Vanlue districts.

The most recent State audit included an unqualified opinion was issued for 2023-2024, including no citations or findings for recovery.

Financial Oversight and Review – A critical component of Findlay Digital Academy’s financial stability and success can be attributed to its experienced and steady leadership team. During the 2024–2025 review year, the long-time superintendent was preparing to retire at the conclusion of the school year. Her successor worked alongside her throughout that year to ensure continuity and a smooth transition, officially assuming the superintendent role at the start of the 2025–2026 school year. While new to community school leadership, he brings extensive administrative experience from traditional public schools. The former superintendent also continues to serve in a contractual role, offering additional support and consultation as needed. The treasurer, who has served the school for many years, provides valuable continuity and deep financial expertise. Their knowledge and understanding of community school law and finance is thorough and current. Findlay Digital Academy student enrollment remained steady during the 2024-2025 school year. Enrollment went from 168 FTE in the previous year to 194 FTE.

3. Organization and Operation – Exceeds

Findlay Digital Academy works with local and regional districts to enroll students who are behind normal matriculation and academic progress and who are considering leaving their home school district.

Findlay Digital Academy’s priority is to support students with an educational plan designed to allow them to progress toward their educational goals.

Findlay Digital Academy in partnership with the sponsor follows the community school contract and exceeds compliance in all areas. Findlay Digital Academy Governing Board members have attended the Auditor of State training on Sunshine Laws, have completed paperwork for disclosure of conflicts of interest, and all have been fingerprinted. The Code of Regulations is followed in detail by the Governing Board of Directors for Findlay Digital Academy.


4. Legal Compliance – Meets

The Governing Board of Directors for Findlay Digital Academy meets regularly in oversight of the policies and procedures as implemented through the delivery of the educational services to students. The Board employs a treasurer who is knowledgeable of community school rules and responsibilities and provides appropriate reports to the Board for analysis and review. The Board also employs a superintendent who has expertise in the community school rules and regulations and monitors the delivery of service of the educational plan. As laws are enacted, Findlay Digital Academy and Mid- Ohio ESC monitor and implement all legal changes.

Mid-Ohio Educational Service Center's current Sponsorship Contract with Findlay Digital Academy is in effect from July 1, 2024, to June 30, 2027. Throughout the term of the contract, adjustments/modifications to the contract for Findlay Digital Academy have been and will continue to be made to reflect any major compliance changes that are enacted by the Board or to reflect any changes in law and rules in the state of Ohio that pertain to Community Schools.
