Tax Rate Hearing/Regular Session

Board President Emily Davies called the Tax Rate Hearing to order at 6:58 pm. Board members present were Emily Davies, Darin Kincaid, Jamie Clevenger, Levi Mallory, Cassie Kleeman, Sharon Wright, and Jake Haley. Board Member Cassie Kleeman joined the meeting via phone at 7:05 pm. Also present were Superintendent Daniel Street, District Bookkeeper Brooke Westcott, High School Principal Chad Boyles, and Elementary Principal Tyna Morrison, SpEd Director Nicole Kelly, Elementary educators Katy Rogers and Traci Heussner, as well as legal advisors Anthony McDaniel, Annette Wallace, and Cody Wieggers of Guin Mundorf.

Board President Emily Davies called the regular session meeting to order at 7:01 pm with a roll call.

Jamie Clevenger made a motion to approve the agenda. Sharon Wright seconded the motion and all present members voted yes.

Jamie Clevenger made a motion to approve the consent agenda, including previous Board Meeting minutes, financial statements and payment of bills, and the current substitute list. Jake Haley seconded the motion and all present members voted yes.

Jamie Clevenger made a motion to approve the Dual Enrollment drop procedures as presented. Emily Davies seconded the motion and all members present voted yes.

Jake Haley made a motion to approve the RCMH Occupational Therapy service agreement as presented. Sharon Wright seconded the motion and all members present voted yes.

Emily Davies made a motion to approve the BTC Bank Mascot Debit Card agreement as presented. Sharon Wright seconded the motion and six members present voted yes. One member abstained.
