

RETURN ON INVESTMENT 2025

In Barbers Hill ISD, our tax dollars are an investment with some of the highest returns in the state!

- BHISD homeowners pay one of the **lowest tax levies** of all public school districts in the greater Houston area after all qualifying exemptions.
- BHISD Board of Trustees grant the **highest optional exemptions** in the state for both general homestead and over 65!
- BHISD is one of an elite group of 23 school districts in Texas with the **highest credit rating** of AA+ by S&P and received a Aa1 rating upgrade from Moody's, one of their highest ratings.



- BHISD is one of the few districts in which the district **AND** every campus scored an **A** on the state's academic accountability rating system for **three** consecutive years!
- Two students were named **National Merit Finalists**, representing the top one-half of 1% of the nation's high school graduating seniors!
- BHHS has won the UIL Academic Team District Championship for a remarkable **28** consecutive years during 3A, 4A and 5A classifications.
- Ten high school students advanced to state **Academic UIL** competitions.



- Barbers Hill Salt Dome Theatre earned fifth place overall in the state UIL **One Act Play** competition.
- The Soaring Eagle Band earned a spot at the state **Marching Band** competition!
- High school choir had 52 students qualify for the **State Solo & Ensemble** contest.
- Texas Association of Future Teachers, Business Professionals of America and HOSA were **national competition** qualifiers.



- BHHS had **15 out of 16** athletic programs advance to post-district competition and **11** athletic programs reached state-level competitions.
- Four track and field athletes advanced to state, including a **back-to-back State Champion** in triple jump, two swimmers, the girls soccer team, boys golf team, boys cross country, baseball, softball and boys doubles tennis team.
- Top 10 finish in the **2024-25 UIL Lone Star Cup** standings.
- **Special Olympics** teams advanced to state in volleyball and soccer.

INSTALLMENT PAYMENTS OF CERTAIN HOMESTEAD TAXES

Taxpayers who have an over 65, disabled or disabled veteran, or spouses of disabled veteran exemption on their primary homestead may qualify to pay current taxes in four equal installments, if they enter in the installment agreement with the Barbers Hill ISD Tax Office by January 31. The exemption must show on your current tax bill. You may make your payments in four equal installments without incurring penalty and interest, if paid in the following manner:

1st payment due by January 31

2nd payment due by March 31

3rd payment due by May 31

4th payment due by July 31

DEFERRALS

If you are 65 years of age or older or disabled and the property described on the tax statement is your primary resident homestead, you may contact the Chambers County Appraisal District regarding any entitlement you may have to a postponement in the payment of these taxes.

PENALTY AND INTEREST

Taxes are due by January 31. Payments received after January 31 are subject to the following penalty and interest rates:

April	8%	3%
May	9%	4%
June	10%	5%
July*	12%	6%
August	12%	7%
September	12%	8%
October	12%	9%
November	12%	10%
December	12%	11%
January	12%	12%

*Accounts not paid in full by June 30 of the year in which they become delinquent are referred to the delinquent tax attorneys for collection and incur an additional penalty equal to 20% of the total taxes, penalties and interest due.
