### **Flexible Parent Meetings**

Pompano Beach Middle school will schedule meetings to be held at various times during the day or evenings to better accommodate parents. Teachers will hold conferences with team and individually to address student concerns. Also, the school will host several academic literacy trainings where childcare will be provided. In these trainings, parents will be taught specifically how to navigate Pinnacle, Virtual Counselor, and other technology.
