# WHAT IS TITLE I?

A federal program that provides additional funds to ensure all students have fair, equal, and significant opportunities to obtain a high-quality education

It focuses on improving the academic achievement of low-achieving students in schools with high concentrations of children from low-income families

# SCHOOLWIDE TITLE I PROGRAMS

## Basic components of a schoolwide program:

- Comprehensive needs assessment
- School improvement plan
- Annual review and revision of the school improvement plan

## Each school and the district have specific improvement plans:

- School improvement plans - approved annually by the district
- District plan - approved annually by the Georgia Department of Education

A copy of the improvement plans can be requested from the FCHS Parent Liaison, Dawn Heaton, or accessed on the district or school websites.

# How Do We Measure What Our Students Are Learning?

## Regular Classroom Assessments

Teachers regularly use assignments and classroom assessments to make decisions about what students are learning.

## Benchmarking Testing

MAP assessments

- 6th-8th grades in ELA and Math
- Given in the fall & winter each year

## State Required Tests:

- Georgia Milestones Assessment System
  - Proficiency level are explained on the website
- WIDA ACCESS testing for students who participate in our ESOL program

\*No one item listed above is the sole basis for educational decisions.

Multiple data sources are used in the decision making process to determine the need for additional learning supports for students.

# PROFESSIONAL QUALIFICATIONS

In Georgia, under the Official Code of Georgia Annotated (O.C.G.A.), state certification requirements are established by the Georgia Professional Standards Commission (GaPSC).

Georgia law also allows school districts to waive certification requirements in Title 20 if the school district has an approved Charter or Strategic Waiver Application.

Fannin County has an approved Charter from the Georgia Department of Education. If we choose to waive state certification we must establish professional qualifications (PQ) for our teachers and report those requirements in our annual ESSA application - the Consolidated LEA Improvement Plan (CLIP).

Parents have the right to request the professional qualifications of any teachers or paraprofessionals that work with their child.

# PARENT ENGAGEMENT POLICIES
