

West Linn-Wilsonville School District

Report on Compliance with Public School Standards

2024-25 School Year

By November 1 of each year, school district superintendents are required by [OAR 581-022-2305: District Assurances of Compliance with Public School Standards](#) to report to their community on the district's status with respect to all of the Standards for Public Elementary and Secondary Schools. 		For 2024 -2025, the district met the 1:60 ratio for the total enrollment. In looking at individual schools, there is one school where two more staff need training, at another school there is one additional person who needs training, and at one another additional school, another .5 staff member needs to be trained to meet the ratio. As a district, WLWV is 29 staff members over the 1:60 ratio. Trainings are scheduled throughout the school year and human resources is tracking this. This is only accounting for staff who were trained in the district or as part of their role. There are staff who were trained outside of the school district but not included in the tracking. All staff are trained annually in district and building emergency plans.
