We post Essential Standards from Missouri Learning Standards on on District Website. All student grades are accessible online and we provide quarterly paper copies for families without internet access. Teachers discuss all of this with parents at Curriculum Night, Meet the Teacher Night, and at fall Parent/Teacher conferences.

Programs offered to families include: summer book program, Bright Futures Station 42 for clothing and home furnishings, school Family Nights, Community Classroom Buddies (business partners which pair with one or more classrooms), Lunch Buddies (community volunteers).

Parent communication is tracked at the individual classroom level, along with purpose of the communication. Parent input and needs are gathered and used to improved family programs. Teachers and other support personnel and administrators review with the federal programs director and the Title I.A

We have increased the number of Title I teachers at K-2 grade level to provide great interventions for students. We also have other programs through Bright Futures including food backpack program, school social worker to address physical and social needs to help with mobility issues. We also provide transportation and information/resources to outside agencies to help meet needs of families.
