• The percent of students identified as Students with Disabilities scoring College and Career Ready (CCR) on the Reading End of Grade assessments in grades 6-8 will increase from 4.0% in SY2024-25 to 14% in SY2025-26. (Aligns to A4.01, B3.03, D1.02 and CMS Guardrail 1)





Here are some strategies that we will be implementing to improve student outcomes:

- Data-driven Centers with intentional instructional support
- PLC planning sessions with ECGC teachers and General Education teachers intentionally planning content
- Intervention block with specific supports aligned to IEP goals
- Tutoring provided for all content areas
