

The Discipline Committee of the Rockbridge County School Board held a special meeting on Wednesday, October 22, 2025 at the Rockbridge Innovation Center.

Present: Trustees Corey Berkstresser, Catie Brown, and Lenna Ojure; Randy Walters, Chief Operations Officer; Ashley Rhodenizer, Discipline Committee Liaison.

CALL TO ORDER:

Trustee Berkstresser called the meeting to order at 5:29 p.m.

Under Section 2.2-3711.A (2) of the State Code, Trustee Brown recommended that the Board go into a ***Closed Meeting*** to discuss one student discipline matters. Motion was made by Trustee Brown, seconded by Trustee Ojure, and passed by 3-0 vote.

The Board entered into the ***Closed Meeting*** at 5:29 p.m.

The Board returned to open session at 6:41 p.m.

Trustee Brown read the following motion to Certify the Closed Meeting:

WHEREAS, the Rockbridge County School Board has convened a closed meeting on this date pursuant to an affirmative recorded vote and in accordance with the provisions of the Virginia Freedom of Information Act; and

WHEREAS, Section 2.2-3712.D of the Code of Virginia requires a certification by this School Board that such closed meeting was conducted in conformity with Virginia law;

NOW, THEREFORE, BE IT RESOLVED that the Rockbridge County School Board hereby certifies that, to the best of each member's knowledge, (i) only public business matters lawfully exempted by Virginia law were discussed in the closed meeting to which this certification applies, and (ii) only such public business matters as were identified in the motion convening the closed meeting were heard, discussed or considered.

Upon initial motion of Certification of Closed Meeting by Trustee Brown, and seconded by Trustee Ojure the motion passed by the following roll call vote:

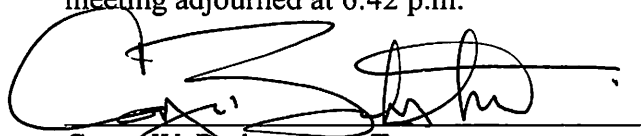

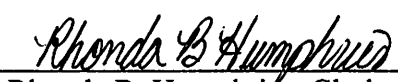
Upon motion by Trustee Brown, seconded by Trustee Ojure, and passed by unanimous vote, the following action was taken regarding student case number 2526-098-10 as a result of a violation of the student code of conduct.

1. Student will be assigned to the Pre-GED/ISAEP program.
2. Mr. Walters will schedule pretesting for student, coordinate times for testing, and arrange transportation for student.
3. The family is encouraged to complete a CSB intake appointment as soon as possible.
4. Student will be enrolled in an online math and reading course to help build skills in preparation prepares for GED testing. Student will receive support from case manager while working on courses.
5. The school will complete a FAPT referral for student.
