The work session was called to order/Instruction for Public Comments: President Warren at 6:02 p.m.



	<p><b><i>Revisit Admin Compensation Package</i></b> Mr. Darga explained that the package has been on previous agendas for discussion. Basically, at this time, they are just looking for approval of the bank day cash out portion of the package. Currently the agreement with the APEA is for the admin cash out to be after 20 years of service and they are proposing to change it to 10 along with the same percentage that is in the chart. The vast majority of administrators will never reach 20 years although it is common for teachers. Any excess not paid out would get put in the cash drop bank, the same bank of time as the teachers. Discussion included board members' questions and concerns. President Warren said that the group had a good conversation and the buy back days should be on the next regular agenda for a vote.</p>
	<p><b><i>Discuss Draft Athletic Coordinator Job Proposal</i></b> Mr. Jimmy Victor was present and explained that demands are growing and the high school is trying to bring in more and more to the district including hosting events. On days that there are multiple games in different locations, he can't be everywhere and an athletic coordinator could help.</p> <ul style="list-style-type: none"><li>• Options were discussed such as putting it on Schedule B, maybe by season to see how it works and ensuring that administrators are present.</li><li>• Board members would like to see an actual proposal to vote on.</li></ul>
