



**News Release – Attempted Motor Vehicle Stop**  
**November 17, 2025**

***Summary:***

On 11/17/2025 at approximately 5:23 PM, Officers attempted to conduct a motor vehicle stop for motor vehicle violations observed on Kane Street in West Hartford. The vehicle got on I-84 westbound where officers attempted to conduct a motor vehicle stop, just east of exit 43. The offending vehicle took off at a high rate of speed, proceeding off exit 43. The vehicle was not pursued, however officers were able to observe the vehicle in various parts of town and successfully deployed a tire deflation device.

At approximately 5:29 PM, officers later observed the vehicle was involved in a motor vehicle accident in the area of Kane Street and Prospect Avenue. The suspect was placed under arrest and transported to the hospital for minor injuries. The vehicle in which the suspect vehicle had struck was occupied by juvenile passengers who were transported for precautionary evaluation.
