**SPEAKER** D. Screven expressed concerns about safety and security within the district and inquired whether the district has considered implementing a weapons detection system.

**III.B. BOARD MEMBER COMMENTS**

T. Hatcher thanked the public speakers, assuring them that the board hears their concerns. She recognized Latino Heritage Month and expressed pride in the district's diversity. Hatcher emphasized that student safety is a top priority for the board and that their responsibility to the community is taken seriously.

K. Johnson echoed Hatcher's comments and concerns, noting the budget impasse at both the state and federal levels. He emphasized that the district never wants any parent to feel that their child's safety is compromised. Johnson explained that the purpose of the referendum is not only to build a new school but also to provide equitable education and access to programs for all students. He highlighted that the current tax structure is unfair to residents and homeowners, and the proposed plan aims to be more equitable by distributing the burden across all working taxpayers. He encouraged residents to review the information, ask questions, attend board meetings, and seek answers.

J. Hill addressed A. Murphy regarding her child being bullied, stating that the district does not tolerate bullying and thanking her for speaking up.

**ATHLETIC DIRECTOR'S REPORT**

**7.B. Lance Deane** reported that the district is reviewing end-of-year academic eligibility rules, noting that currently students failing two or more classes must sit out the first 15 school days of the following year, which can penalize students who fail a half-year class. He highlighted the "Alert Your Athletes" protocol, where coaches contact students who are failing. Deane also recognized athletic achievements: Girls Tennis Mid-Penn qualifiers—Sopia Fields, Suha Rockwell, Savannah Morris, Tuba Noor, Miranda Jiang, Presus Tamang, and Natalie Pickering; Cross Country Mid-Penn qualifiers—Anthony Do, Aidan Faulkner, and Nevin Claudio; Girls Soccer—Reading High School Tournament Champions; and the football team, currently 7-0 and ranked first in the district. He noted successful youth nights for Field Hockey and Football, the first edition of the first Athletic Newsletter, and that the BSN apparel store is now active.
