

AMENDMENT NO. 1 TO
AGREEMENT FOR EMPLOYMENT OF BUSINESS ADMINISTRATOR

THIS AMENDMENT NO. 1 made this _____ day of _____, 2025, by and between the **Board of School Directors of the Wallingford-Swarthmore School District**, a Pennsylvania school district with its principal office located at 200 South Providence Road, Wallingford, Pennsylvania 19086 (hereinafter referred as “District” or “Board”) and **DeJuana Mosley** (hereinafter referred to as “Ms. Mosley,” “Mosley,” or “Business Administrator”).

WITNESSETH:

WHEREAS, District and Business Administrator are parties to an Agreement for Employment of Business Administrator dated December 18, 2023 (hereinafter “Original Employment Agreement”);

WHEREAS, it is the intent of this Amendment No. 1 to amend the Original Employment Agreement to provide for an adjusted annual salary for the Business Administrator for school year 2025-2026 and establish the basis for increases during the 2026-2027 school year;

NOW, THEREFORE, the parties intending to be legally bound, and in consideration of the mutual covenants contained herein, agree as follows:

1. Amendment of Paragraph 3.a.-c., Regarding Annual Salary Base Compensation. Effective July 1, 2025, notwithstanding the provisions of Paragraphs 3.a.-c. of the Original Employment Agreement, shall be \$200,000.00, less legally required withholdings, payable in biweekly installments. For the 2026-2027 school year, the Board, at a regular meeting of the District, can modify the salary increase set forth in Paragraph 3 of the Original Employment Agreement to a salary adjustment in excess of the amount set forth in Paragraph 3 of the Original Employment Agreement within the sole and exclusive discretion of the Board. The salary increase for the years in question shall supersede the salary adjustments set forth in the Original Employment Agreement and will be in lieu of those increases.

2. Remaining Portions of the Original Employment Agreement. In all other respects, the Original Employment Agreement shall remain in full force and effect, with the exception of the salary increase for the 2025-2026 school year, which shall be inapplicable.
