“I do solemnly swear that I will support, obey and defend the Constitution of the United States and the Constitution of this Commonwealth, and that I will discharge the duties of my office with fidelity.”

(if there are, follow same as above. A motion to close nominations when there are 2 or more nominees requires a 2/3 vote to carry.)

“If there are no more nominations, a motion to close nominations is now in order.”

If there is only one nominee,

“Is there a motion to approve _____ as Board Vice-President?”
