Dear Parent/Guardian:

I hope the school year is off to a successful start for you and your child. I am writing this letter to let you know that Eastern Guilford Middle School has been designated as a Targeted Support & Improvement Additional Targeted Support (TSI-AT) school by the North Carolina State Board of Education. Per ESSA Section 1111(d)(2), schools are identified as TSI-AT schools in North Carolina because one or more of the following subgroups received a subgroup performance grade score at or below the highest identified CSI-LP school's All Students group during the identification year; and is on the TSI-CU list for the subgroup(s) for the previous year. Subgroup performance scores are provided for the following subgroups: (1) Students with Disabilities, (2) Economically Disadvantaged, (3) Black, (4) White, (5) Hispanic, (6) Asian-Pacific Islander, (7) Multi-racial, and (8) English Learners. This letter is to notify our parents and guardians of Eastern Guilford Middle School intentions to improve educational outcomes for underperforming student subgroups and close achievement gaps for all students.

As a TSI-AT (ATSI) school, Eastern Guilford Middle School is required to develop an Additional Targeted Support and Improvement (ATSI) plan that specifically addresses how the school will improve outcomes for underperforming subgroups. The plan will also include strategies that our district or charter will employ to support Eastern Guilford Middle School improvement efforts. The ATSI plan will address the following areas:

- Classroom Management
- Standards-aligned Instruction
- Professional Learning Communities (PLCs)
- Instructional Leadership
- Recruitment & Retention of Effective Teachers
- Support for Grade-to-Grade Transitions
- Implementation of a Tiered Instructional System
- Data-Driven Decision Making
- Student Support Services
- Family and Community Engagement

We have set the following goals for Eastern Guilford Middle School this year:

- Eastern will increase math proficiency composite on the End of Year assessment from 35.7% to 38.7%.
- Grade 6 will increase math proficiency on EOGs to 40.2%
- Grade 7 will increase math proficiency on EOGs to 40.2%
- Grade 8 will increase math proficiency on EOGs to 35.0%
- Eastern will achieve a rating of "Operationalizing (2)" on FAM-S Item 24: Across all tiers, attendance, behavior, social-emotional, and academic data are used to analyze and hypothesize reasons students are not meeting expectations..
- 100% of Eastern's students will engage in experiences that promote awareness of and exposure to diverse career opportunities.

Here are some strategies that we will be implementing to improve student outcomes:

- Implement daily formative checks for understanding to quickly identify and address misconceptions.

- Analyze CFA and Summative data in PLCs to adjust instruction, reteach priority standards, and plan targeted interventions.
- Establish a consistent, schoolwide data-review schedule (attendance, behavior, SEL, academics) every 4–6 weeks.
- Launch attendance incentives and tiered supports, including individualized plans for chronically absent students.

Also, parent engagement is at the heart of our school improvement efforts. Here are some ways we can work together:

- Ensure that both you and your child know the academic expectations set for your child this school year. A list of learning objectives in student-friendly language is available from your student's teacher(s).
- Call Mr. Will Moore at 336-449-4255 if you have questions or concerns about your student or to set up an appointment to meet with a school staff member who will be working with your child.
- Make sure that your child is prepared and attends school each day.
- Monitor your child's homework.
- Monitor the progress your child is making and attend meetings with your child's teacher(s).
