Dear Parents/Guardians & Students:

California State Education Code 49428, Pupil Mental Health Services: School Notification, requires schools to share information with students and families on how to initiate access for available student mental health services on campus and/or in the community at least twice during the school year. We are committed to ensuring access to these services for our students as we recognize that mental health has a direct impact on academic success.

Altus Schools support student mental health and wellness through a positive school culture with safe and supportive learning environments. Through the schools' Resilience in Students & Education (RISE) series, the Healthy Youth Department delivers monthly webinars on Social Emotional Learning that support students' development in the five areas of social and emotional competence. Through professional development, school staff are provided with the skills needed to identify youth in crisis, intervene appropriately, and provide comprehensive support in partnership with families. Teachers and staff participate in **Youth Mental Health First Aid (YMHFA), Trauma Informed Practices (TIPS), Altus Signs of Suicide (SOS) trainings**, and the established mental health reporting and crisis intervention protocols to ensure students and families receive support at various levels of need. As part of a Multi-Tiered System of Support (MTSS), Altus Schools provide **direct mental health services** to students with mental, emotional and behavioral health needs through Licensed Marriage and Family Therapists (LMFTs) and credentialed staff specializing in school counseling. Parent(s)/guardian(s) may initiate access to pupil mental health services by contacting their teacher, counselor, or at the school's Resource Center, and **requesting a referral**. Through this process, families will be connected to available school-based services provided by our Healthy Youth School Therapists, or to community-based services provided by a community-based organization. Additionally, Altus Schools have created an online tool that connects students and families with informational resources. The [Altus Schools Mental Health and Wellness Hub](https://altusgo.com/hub/) provides access to support hotlines, crisis text lines, downloadable resources and information on main topics related to mental health and wellness. School Resource Centers:

Each Resource Center serves as an information hub for available school based mental health supports. You may contact your student's teacher or assigned counselor, inquire about supports available, and request a referral for mental health services.

988 Suicide and Crisis Lifeline:

988 has been designated as the three-digit dialing code that will route callers to crisis support counselors who are available 24 hours a day, 7 days a week, 365 days a year. When people call or text 988, or chat at <https://988lifeline.org/>, they will be connected to trained counselors that will listen, understand how their problems are affecting them, provide support, and connect them to resources if necessary.

California Youth Crisis Line: 800-843-5200

Available 24 hours a day, 7 days a week. The hotline is a statewide emergency response system for youth ages 12-24 and families in crisis. Professionally trained staff and volunteer counselors provide crisis intervention counseling and resource referrals to service providers in the caller's local community.
