School Fees are billed in advance at the beginning of each term with Additional and Extra Charges billed in arrears.

Payment is due on the first day of each term. Interest is charged at 1.5% over the Bank of England base rate per month on any outstanding fees; and monthly thereafter.

## TERMS AND CONDITIONS

1. School Fees, Sport Academy Fees and Additional Charges as stated are inclusive of VAT.
2. School fees include tuition, support for learning, supervision and care, meals, laundry (excluding dry cleaning), travel for school matches and careers counselling.
3. A refundable deposit of £800 for UK domiciled pupils and £5,000 for non-UK domiciled pupils is charged in advance of a child joining the school. This is to cover any extras owing at the end of a child's career at Merchiston and the balance will be returned when the child leaves.
4. A full term's notice in writing must be given to the Head if it is intended to withdraw a child, or a term's fees paid in lieu thereof.
5. A full term's notice in writing must be given to the Head if it is intended to change from boarding to day, or the fee differential for the full term paid in lieu thereof.
6. The School offers a Fees Refund Scheme, which facilitates the recovery of school fees through absence on account of illness; further information may be obtained from the Bursar.
7. Means-Tested Bursaries are available to suitable candidates; further information may be obtained from the Bursar.
8. For parents wishing to pay by Direct Debit, Merchiston Castle School is an Introducer Appointed Representative of Premium Credit Limited which is Authorised and Regulated by the Financial Conduct Authority FRN702718.
