TRACKING THE SHIFT ON YOUR TAX BILL

See the difference at a glance:

- 2024: Reduced but not eliminated.
- 2025: Supplemental levy = \$0.
- 2026: Voter-approved, any tax relief dependent on state revenues.

THE ALLOCATION

\$8.25M

Tax line item: SCH #25 SUPP

Covered the voter-approved SD25 Supplemental Levy.
(Taxpayer Impact: \$0)

\$1.87M

Tax line item: SCH #25 PLANT

Reduced the voter-approved School Plant Facilities Levy to \$5.19M.

A NOTICEABLE CHANGE

- Taxpayers pay \$0 toward the SD25 supplemental levy in 2025.
- Line item **SCH #25 SUPP** removed from tax bill.
- **SCH #25 PLANT** facilities levy cost is also reduced by nearly \$2M.
- These savings are possible because of one-time state property tax relief.

LOOKING AHEAD

While this state funding drives historic tax savings, it does not eliminate the ongoing need for locally supported levies to sustain essential district services.

- State revenues are projected to decline.
- This level of tax relief is unlikely to repeat.
- The supplemental levy is up for renewal in 2026.



These local levies represent a decades-long tradition of voter support that continues to strengthen PCSD 25 schools.
