**BE IT FURTHER RESOLVED** that the Board of Education hereby authorizes the President of the Board of Education to execute the necessary documents to effectuate the Petition, and to take such further action as may be necessary in furtherance of securing such exemption of real property taxes for said Property, on behalf of the Board of Education.
