NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN, that the Board of School Directors of the Easton Area School District will hold a public hearing on January 20, 2026 at 6:00 p.m. prevailing time, at the Easton Area School District Board Room as required by the Act of March 10, 1949, P.L. 30, No. 14 as amended June 27, 1973 by Act No. 34 Section 701.1, 24 P.S. 7-701.1 (“the Act”) relative to the proposed New Easton Area High School and the financing thereof. The “Maximum Building Construction Cost” as adopted by the Board of School Directors is \$205,825,400 and the “Maximum Project Cost” is \$302,314,000 with respect to the New Easton Area High School Project.

A description of the Project (the “Description”) may be obtained from the Easton Area School District administrative offices, 1801 Bushkill Drive, Easton, Pennsylvania, 18040, during normal business hours from 8:00 a.m. to 3:00 p.m. commencing on December 15th, 2025 and including the date of the hearing. In addition, copies of the Description will be available at the hearing. A brief presentation will be made at the hearing relative to the Project.

All persons interested in obtaining additional information with regard to the proposed Project are encouraged to obtain copies of the Description and/or attend the hearing above scheduled. Persons attending the hearing will be permitted agenda time to make statements or present evidence, either written or oral. All persons will be requested to limit remarks to three (3) minutes or less. Written statements are preferred for lengthy presentations. Questions may be asked of the administration but should be submitted in writing and, to the extent possible, in advance, to insure the answers will be responsive. It is the intention of the School Board to make a full and complete record of the hearing stenographically by a verbatim reporter. Evidence and materials presented will be considered by the Board of School Directors in its final determination as to whether to proceed with the Project.

This notice is being given, and the hearing held pursuant to a Resolution of the Board of School Directors duly adopted at a meeting held the 18th day of November, 2025.

Any and all interested persons may appear and attend the public hearing and may be heard at such public hearing. Such persons may also submit letters or written testimony to the Secretary of the Board of School Directors, 1801 Bushkill Drive, Easton, Pennsylvania, 18040 containing their views of and reactions to the Project until January 20th, 2026.
