Base Fee 1 Payment — Due on or before June 30, 2026.

3 Payments*— First payment due on or before June 30, 2026; Second payment due on or before October 31, 2026; Third payment due on or before February 28, 2027.

10 Payments*— First payment due on or before June 30, 2026; Subsequent payments will be due by the end of each month from June 30, 2026-April 30, 2027. No scheduled payment will be due in December 2026.

***Truth in Lending disclosure:** A service charge is added to the base fee payment (full payment) if a 3-payment or 10-payment option is selected.

FEES INCLUDED IN TUITION

- A full-service lunch program provided by Sage Dining for grades K-12.
- The use of a school-owned student device as a part of the Connected Learning Program for students in grades 6 -12.
- A yearbook for each student in grades PK-12.
- Basic school supplies for preschool through grade 8.
- Books/workbooks for kindergarten through grade 5.
- The high school retreat for grades 9-12.
- Student activity fees for daytime, academic activity-related costs that apply to all grades PK-12.
- Senior dues which offset the cost of graduation fees (individual orders or needs for graduation are at the expense of the senior).

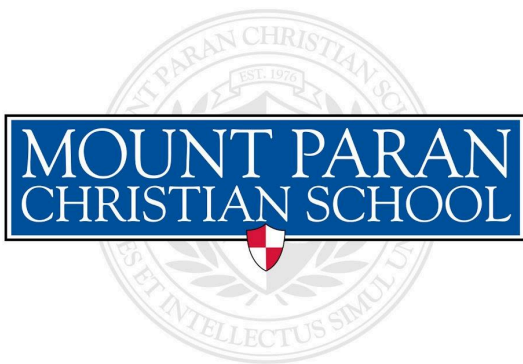
FEES NOT INCLUDED IN TUITION:

- Textbooks /workbooks for grades 6-12.
- Co-curricular and overnight trip fees are assessed according to individual student participation in activities/class trips (e.g. chess club, band, athletics, performing arts, etc.)
- Special services fees (e.g. Encore, Directed Studies, Speech, Bus Transportation, The Zone After School Care) are assessed according to services received.
- Advanced Placement exam fees, if applicable.
- Winterim Experience fees for grades 9-12.

A non-refundable, non-transferable and unconditional application fee of \$95 is due with all new student admission applications.

If accepted, a non-refundable, non-transferable, and unconditional deposit of \$760 (\$750 tuition deposit plus \$10 FACTS submission fee) will be required within 10 days of notification of decision to complete the registration process.

Monthly tuition payments, special services payments, and required fees are due by the designated due dates or a late fee will be applied to the account.

2026-2027 MPCS TUITION FINANCIAL PRACTICES

All tuition payments are payable on the dates specified by the payment plans described in the [2026-2027 Tuition Rates and Payment Plans](#) above. Accounts are delinquent if not paid by the **last day of the month** (June-April, with no payment due in December) and will be assessed a **\$50 late fee for each student**. **Please note, the initial payment is due on June 1 and no later than June 30 or a \$50 late fee will be assessed per student and the student may lose registered placement in a class.**

If an account falls 30 days past due, unless prior arrangements have been made with the Student Accounts Office and at the sole discretion of Mount Paran Christian School, the parents and/or guarantor may be contacted and the student may not be allowed to attend classes until the tuition is paid with an up-to-date status. The account will be subject to appropriate penalties, including all late fees which may have been forced to the extent permissible by law. There are no refunds given in the event of an act of God, government action, terrorism, or epidemic.

Any check or electronic payment returned for any reason will incur a \$25 fee. If returned a second time or if at least one prior check has been returned in this school year, full replacement payment by cash, credit card, cashier's check, or money order will be required within 10 days in order for the student to attend school. In addition, the family forfeits the right to pay any/all fees by check for the remainder of the school year.

Mount Paran Christian School must rely on tuition income to meet operating expenses. Since salary obligations are contractual in nature and are based on income projected by enrollment contracts, it is essential that the income from tuition be assured. If enrollment is canceled or in the event of separation for any reason between the student and the school, other than the stated exception below financial obligations are as follows:

- IF THE STUDENT WITHDRAWAL REQUEST FORM IS RECEIVED PRIOR TO APRIL 1, the Parent will be relieved of all tuition paid and other payments and fees that would have come due after the termination date, less the non-refundable, non-transferable, \$95 application fee and the deposit of \$760 (\$750 tuition deposit plus \$10 FACTS submission fee).
- IF THE STUDENT WITHDRAWAL REQUEST FORM IS RECEIVED ON OR AFTER APRIL 1, Parent is responsible for the applicable portion listed below of the full tuition based on the 10-payment plan.

- New student applications are to include the payment of a non-refundable, non-transferable application fee of \$95.
- New student deposit of \$760 (\$750 tuition deposit plus \$10 FACTS submission fee) is non-refundable, non-transferable, and unconditional without exception.
- Returning student applications are to include the full payment of a non-refundable, non-transferable, unconditional deposit of \$760 deposit (\$750 tuition deposit plus \$10 FACTS submission fee) in order to apply for the 2026-2027 school year. Priority is given for returning students through December 31, 2025.
- All students must have a FACTS tuition payment plan set up at the time of re-enrollment or within 10 days of new enrollment (and prior to school attendance). Enrollment is not considered complete and the student will not be placed on a roster without paid tuition deposit and FACTS payment plan setup.
- The tuition deposit of \$750 for new and returning students will be applied to the total annual tuition balance.
- This contract includes agreement to all policies listed in the Parent/Student General Handbook and special service contracts.
