- Teachers sharing updates and information with families through Parent Square.
- Advertising important Parent and Family Engagement (PFE) events on our **school marquee**.

Annual Meeting and Program Explanation

Flexible Opportunities for Engagement

Thomas C. Boushall MS is committed to offering flexible and accommodating opportunities for parent engagement. Meetings will be scheduled at various times, including mornings and evenings. When possible and supported by Title I funds, **Thomas C. Boushall MS** will provide services like transportation, childcare, or home visits to help families attend.

- Disseminating important information to parents through **calls and text messages**.

Timely Information and Accessible Meetings

Thomas C. Boushall MS will ensure that parents receive timely information about Title I programs, along with clear explanations of **Thomas C. Boushall MS's** curriculum, academic assessments, and expected proficiency levels. - **Report cards** are shared and reviewed with families to discuss student progress.

Submission of Unsatisfied Comments

If parents are not satisfied with the schoolwide program plan, their comments will be collected and submitted to the Local Educational Agency (LEA) upon sharing the plan.

- Administering **school satisfaction surveys** annually.
- Using **exit tickets** during PFE events to gather immediate feedback.

- Utilizing **interactive parent logs** to track and support learning activities.

Staff Professional Development

Thomas C. Boushall MS will also provide professional development for teachers, specialized instructional personnel, and other staff to increase understanding of the value of parent engagement and the essential role of families and communities in promoting student achievement.

Staff development will include:

- A dedicated portion of **August In-Service Training** focused on parent engagement.
- **Staff meetings** with a dedicated focus on student attendance and the role of family connection.
- **Regular professional development meetings** that focus on best practices for family and community engagement.

Coordination and Integration
