



Tuition, Payments, and Fees 2026-27 School Year

A Kents Hill education is an investment and we are mindful of the sacrifices that families are making to support their children in receiving the very best education possible. After reviewing our various flexible payment plans and options, we hope that you will find that the opportunity for your child to attend Kents Hill is achievable.

Tuition Deposit

Kents Hill requires a non-refundable enrollment deposit of 10% of your total tuition to reserve space for the school year. This will be applied to the student's tuition account.

Flexible Payment Options

We offer three different payment options administered in partnership with SchoolAdmin.

1. Full Payment: One payment of tuition and fees made on or before June 15. If the payment is received in full on or before June 15, a 1% discount will be credited to the student's MyKidsSpending account by the start of school.
2. Two Payments: 60% of tuition and fees by June 15 and 40% by October 15.
3. Monthly Payments: Families pay monthly starting in June and ending in March. Late enrollment in this plan is possible, but all payments must be completed in March.

The tuition insurance plan is required unless the full year's tuition and fees are paid in full by June 15 and families complete an opt-out form. If a student permanently leaves school during the year, the plan provides a prorated refund of unused tuition under certain conditions. The fee is listed on the enrollment agreement.



All tuition accounts must be paid in a timely manner. Invoices are emailed to families through SchoolAdmin. A late fee of \$25 may be applied to the account if payments are not made on time.

Please note that if a student leaves or is dismissed from school, the family is still responsible for the full year of tuition and fees as signed and agreed on the enrollment contract.

Financial Aid

As part of our commitment to helping students and their families afford a Kents Hill education, we offer need-based financial aid. Awards are made on a rolling and competitive basis to students of proven ability and achievement whose families demonstrate financial need. To be considered for financial aid, families must complete the financial aid application online at <https://auth.clarityapp.com/signup>. The best time to apply for financial aid is prior to December 15 for Early Decision students and prior to January 15 for Regular Decision students.

Payment Methods

Enrollment deposits made by credit card or wire transfers are preferred. For your convenience, payments by MasterCard, Visa, or American Express are accepted for enrollment deposits.

1. Wire Transfers: For wire transfer information please contact the Admissions Office at hello@kentshill.org or 207-685-1606. Please indicate the student's name and tuition amount.
2. Credit Card Payments: Permitted for enrollment deposits only. All other tuition payments must be made by wire transfer, or ACH through our SchoolAdmin portal. To pay your deposit, visit kentshill.diamondmindinc.com.
