The Ascension Special Education Advisory Council (Ascension SEAC) is an opportunity for parents, district staff, and community stakeholders to provide advice and feedback regarding special education policies, procedures, and resources. The members of Ascension SEAC shall engage in outreach activities in the community to increase the level of knowledge, support, and collaboration in regard to special education. The council will consist of at least eight members, at least 50% shall be parents of a child who receives special education services, one shall be an Ascension Parish Principal, Teacher or Paraprofessional, and one shall be a special education stakeholder. Each member will be appointed for a two school year term and will act as an advisory council to the superintendent and/or the school board. The Ascension SEAC will meet six times per school year.

Please NOTE that SEAC meetings are conducted similar to board meetings (open meeting forum). Council members discuss agenda items and make recommendations. Robert's Rules of Order are followed. Attendees can make public comment on agenda items by making a request at the start of the meeting.
